Bob Hausermann called the meeting to order. Lisa Allen led in prayer. The pledge was recited; and roll was taken. B. Hausermann; present. Ray Autenrieb; present. Jack Kuntz; present.

Captain Bob Rose read a letter from the Clermont County Sheriff's Officer commending Corporal Ron Robinson.

Chief Pegram updated the board on two trips he represented Goshen Township at no cost the township except the time. The National Conference went very well and was very valuable to the Chief. The Congressional Fire Service Dinner was valuable and he discussed funding there. He met with Jessica Witmer from the Goshen Chamber of Commerce and they are discussing with Administrator Snyder about moving the Movie night to behind the Fire House for June and July. Lou Clemons updated the board on the question from Bob Hausermann regarding decoration for the township. The cost would be \$600 for just American Flags, \$4,400 for seasonal flags. The board all agreed that American Flags will be sufficient for now and may consider seasonal flags later. They discussed the payment of the flags and decided they can pay from an existing line item.

Ed Cassidy donated \$100.00 to the Fire and EMS Department as a thank you.

Chief Pegram updated the board on the purchase and financing of a demo ambulance (documentation is attached). Ray Autenrieb asked about used vehicles. Chief stated they have but have not found one. The Department would like to have a vehicle that will have a warranty. We are not finding a vehicle with the low mileage. They discussed the ambulance that is currently out of service. They discussed the payment and Chief informed them the payment this year payment will be covered from increase in billing revenue and sale of old ambulance. Jack is in favor and sees this as the biggest need. Wants to know the timing. Steve stated that the numbers will not change but the availability of the ambulance could change. It is first come first serve. Bob Hausermann and Ray Autenrieb are also in favor. When the other ambulance is out of service and stuck at the hospital for example, we are also losing employee time. Lisa Allen asked about the payment for this year and Chief Pegram said we would not need anything from the General Fund.

*** Bob Hausermann moved to ask Chief Pegram to proceed with purchase of F350 ambulance from Horton Emergency Vehicles for \$120,000. Ray Autenrieb seconds; motion carries. B. Hausermann; yes. R. Autenrieb; yes. J. Kuntz; yes.

Bob Seyfried agreed with the decision. George Jones asked about other needs the Fire and EMS department had like uniforms and Chief informed him that they were ordered. Jim Constable asked about the repair costs and doesn't understand why an ambulance is worn out with such low mileage. Chief Pegram explained that it is not just the mileage but he hours used. He asked if it was a good idea to purchase an ambulance and not buy radios. Chief stated not of it is a good idea to forgo which is why we needed the levy to pass and they are working off a priority list. Ken Klosterman asked about the levy threats and why there were no cuts and Bob Hausermann stated that has already been discussed. Carl stated we need help and we should not look at the past but forward.

*** Jack Kuntz moved to execute a lease purchase agreement with Republic First National Bank in the amount of \$120.000. Ray Autenrieb seconds; motion carries. B. Hausermann; yes. R. Autenrieb; yes. J. Kuntz; yes.

Jim Constable – 1785 St Rt 28, Lot 209 – He gave a 12 page hand out. He questioned the Medicount information. He requested the cd from the meeting. It would not play. He said thank you to Ray Autenrieb for listening to his concerns. Thank you to Teri for getting a new copy that would work. Lisa notified them that the original cd had a virus. He asked about the minutes. He is questioning the amount that Medicount keeps. He would like the township to get more than Medicount. Bob Hausermann stated that it is the amount they charge and it is better than none. He questioned when the meetings occurred. He is concerned about spot zoning, PUD. Bob Hausermann stated that the Zoning Commission is working with this. There is an appeal process if that is not satisfactory. Bob Seyfried explained how it benefits them and the community to go with the ruling from the Zoning Commission. The zoning has not been sent to the Planning Commission. Jim asked what the procedure is. 1st Public Hearing is when they apply for change; then 2nd Public Hearing with the Zoning Commission; then 3rd is with the Planning Commission then it comes back to the board and they can vote. Bob Hausermann said he would have the Administrator follow up. He then asked about the TIF's and Bob Hausermann stated he is still working with the County to negotiate. Jim stated that we are spending the townships money for a subdivision that is not giving the township any.

Ken Klosterman – He said thank you to Lou Clemons for helping the Historical Society. He asked the people to take interest. He asked about the Goshen Sign being faded. He informed the audience that they Historical Society is putting up a split rail fence around the log cabin.
