Jack Kuntz asked if people can ride their horses and Joe responded yes they have been and can ride.

Bev Busam – Moler Rd. I live right next to Robert Harbor. I have concerns and wanted to know what the township is going to do to protect the privacy and safety of the neighbors during the filming. Trustee Jack Kuntz asked her to stay after the meeting and he will address her concerns in detail the best he can.

Jim Constable - 1785 SR 28 Lot 209 - Gave handouts of February 18, 2011 budget and a Revenue Status Report as of March 31, 2011 which shows an increase of \$135,972.00. He would like to know where it came from and where it went. He will leave the reports to be looked over and the trustees can get back to him with an answer. Bob Hausermann asked Lisa if she had the answer and Lisa responded she did not have an answer at this time. In reference to the Zoning Case 298, he sees where it has been advertised for public hearing with the Zoning Commission and the Trustees. He stated there were 4 issues from the Planning Commission. Zoning had no clue if any changes on SR 28 has to go thru ODOT. He called ODOT and ODOT informed him that everything has to go thru them. He stated that someone needs to educate Zoning as to what needs to be told to the people with questions and its free to go thru ODOT. He did give Teri the gentleman's name and number. The Consent to Re-zone forms dated 2001 needs to be updated to say 2011. He also stated on the flow chart of the Zoning Resolution states all adjoining property owners must be notified, somewhere it was changed to adjacent, this needs to be corrected. The final thing is the Business PUD on page 118 of the Zoning Resolution states you SHALL have 10 acres. If this is true you cannot have this zoning case a Business PUD, someone needs to check on this cause the resident has been waiting since November. Bob Hausermann stated he will look into it and expedite as quickly as the law allows. He stated the Fund Summary statements from last month were not on the table and Lisa responded they were not available due to the meeting being moved up and the bank statement not available to complete the report. He also stated that as of April 2011 expenses were 2 million of the 4.3 million dollar budget, and the trustees need to look into the rate of spending.
