Steven Holland, State Route 48, spoke regarding the phenomenal job the Fire Department is doing and why we needed the money.


Resident, Parker Road, stated that the letter given to Donald Combs says one dumpster. The property is a mess and the Trustees are doing nothing to remedy the problem.
