Community Forum

James Constable stated that some of the things he brought to your attention at the Budget Meeting, he would really like someone to look at it. He would like someone to set the newspaper straight on their article that was printed on February 22 saying the budget was almost 2 Million over last year. That is an incorrect statement. It was almost half a million. He talked about the TIF's. He stated that the Trustees were talking about eliminating the existing TIF's.

Ray Autenrieb stated that Bob Hausermann is working with Commissioner Proud.

Bob Hausermann stated he has been in contact with Commissioner Proud and he is checking into the situation over there right now.

James Constable stated that if they could get the TIF's cancelled, that would probably be around \$150,000.00 more revenue for this township. He stated that at the last meeting he asked the Trustees to explain why on December 30, 2011 the estimated resources was 6.3 million dollars and 19 days later on January 18, 2012 it was \$544,000.00. That's \$914,000.00 almost a million dollars swing. I still don't have an answer to that. I would like someone to address that. He stated that at the last meeting he asked for copies of the bills for October, November and December. The October's bills that were handed out at the meeting, versus what the Fund Summary sheet that was handed out was off by about \$703,000.00. Novembers was off by about \$211,000.00 and Decembers was off by about \$867.000.00. He still does not have an answer for that.

Ray Autenrieb stated that he had spoken to Lisa that morning and she said she had received the written request.

James Constable stated he had given the Trustees a list of things that he would like them to consider in order to have more revenue come in to the Township. One of them is eliminate all the legal fees. There is \$20,000.00 budgeted for legal fees.

Ray Autenrieb stated he had told Mr. Constable that morning the money was for the Unions. The County Prosecutor will not represent us for that.

James Constable stated, so we are going to continue to spend 15 – 20 thousand

dollars a year for legal fees.

Ray Autenrieb stated that as long as there is still a union, they have to have their negotiations, he is afraid so.

James Constable said the Trustees should consider selling the property at 1910 Main Street.

Ray Autenrieb said they would take that into consideration when the economy picks up.

James Constable said the Trustees should sell the 6.2 acre park. If you can sell that you won't have to maintain it.

Ray Autenrieb responded stating they have had a couple of people look at it but the deals fell through, so it is up for sale if anyone wants to buy it.

James Constable said the Trustees should consider doing in house billing for the Fire/EMS. You are presently paying about 7% on that.
