Joe Spaulding gave an update on the Marr/Stagge Park. Joe stated that the weather is not cooperating and all the rain has held up the planned progress on the Frisbee golf course. It's also not allowing the gravel to be brought in to finish the parking lot. Bob Hausermann has donated 100 ton of ground up concrete that he and his trucking friends will be bringing in to help finish the parking lot. The basic playground equipment has been ordered and should arrive within 4 to 6 weeks. Money for this was donated by an anonymous family. A grant has been received to put in a rain garden. Two existing insurance policies have been combined into one with State Farm and cut the cost from \$2,150.00 to \$1,020.00 per year. Bob Seyfried and his men assisted by putting a tire back on our equipment. The Goshen Park District is in need of rocks and stones to be picked up and put in the small ditches and gullies that wash toward the pond. The barn, corncrib and shed behind the house are going to be painted.
