The minutes of July 5, 2012 (Special Meeting – General Business) will be held until the next meeting, as the Trustees have not had the opportunity to review them.

Communication and Announcements

Claire Corcoran spoke about an upcoming event in Goshen named the 12 Days of Christmas. The Goshen Homeowners Association is organizing the event and will start with the Light Up Goshen Parade, which the Chamber takes care of every year. The Holly Fair is also going on at the school. We are asking that residents and each community organization get involved to make this event a great thing for Goshen. There are several activities that are already being planned but we need a community effort, including the Veterans, Parks and Chamber. This Thursday

evening beginning at 7:00 PM there will be a general meeting held at Heritage Hall for anyone who would like to attend. Lois Pappas Swift and Mike Swift are allowing us to have the meeting there to get it started. One of the days will include a live creche at the park. The Goshen Horse Thief Detectives will be responsible for the duties and providing the animals. Beck's Hardware nas said they would allow us to do a food drive in their parking lot. Goshen Gardens is also going to be involved in the food drive. We are going to have a day of carriage rides. On December 11, 2012 the Goshen Library is going to do a story reading and a craft event. Would like for the children to get together with the Veterans to make and send Christmas Cards for the Veterans who are here in the hospital. Claire Corcoran is the contact for this event. Captain Bob Rose thanked Officer Wolf, Officer Michael Bishop and Officer Jason Lagore on behalf of Goshen Township, Goshen Township Trustees, Goshen Police and Fire Department and commended them for their life saving actions rendered on August 27, 2012. Officer Jeff Wolf responded at 6:16 PM to a report of a missing 88 year old man who's address is on Thompson Road in Goshen Township. Upon arrival, he recognized the urgency of the situation, and contacted a supervisor, activated canine units and continued exhausting any potential leads on the whereabouts of the missing man. At the time, the nearest available canine units were Officer Michael Bishop of the City of Mason Police Department and Officer Jason Lagore of the Ohio Department of Natural Resources. Both Officers responded quickly and began working together searching woods and fields. The victim was found within an hour of their arrival. The Goshen Township Fire and EMS Department, assisted by Officer Wolf extricated the victim from the woods and EMS rushed him to the hospital where he was stabilized. Officer Wolf, Officer Michael Bishop and Officer Jason Lagore were presented with a certificate of appreciation. The daughter of the victim thanked everyone for their help and their ability to keep her and the neighbor calm in the situation.

Community Forum

Steve Myers 742 McClellan Road Milford Ohio – Running for State Representative 65th Ohio House District. He is a 55 year resident of District 65 and went to school at Milford High School. Son and Daughter just earned their degrees. Son interned for the Senator last summer. Senator asked him to send him a resume, commenting about his experience in Human Resources. He has created over 10,000 jobs. He worked with companies like General Motors, General Electric and UPS. He took classes in economics, psychology and leadership. He owns a small consulting business and has great work ethics. His motto is “go big or go home”. Mr. Myers has ties to Goshen through the Florence family. His nephew designed the 1819 Goshen flag. Mr. Myers talked about some plans he would like to implement here in Goshen which would bring a lot of prosperity to this area. He spoke about the largest chemical waste dump located in Jackson Township called CECOS. If we could get this designated as a “super fund” site and get it cleaned up. This would employ many people. He wants to get the University of Cincinnati involved. He is proposing to build a training facility here and put people to work. He asked if we would go to his website to review his plan for school reform. He is proposing to get rid of HB920 and implement light rail.

Ray Autenrieb said he would like to invite Mr. Myers back at a later date.


