Park Board Update – Joe Spaulding, President gave an update. Goshen Park Commission released its 2013 wish list for Stagge-Marr Park. The Park Commission held a Special Meeting to review ideas about possible improvements to the park facilities. Topping the list were the Lion's Shelter dedicated last fall, a new playground donated by the Klosterman Family and the completion of a new 18 hole disk golf course called Osage Grove. The park pond needs a solar or wind powered aerator and a gazebo or structure that would provide shade and a pond focal point. An upgrade on the electrical service is needed so that larger events can be hosted (i.e. lighting outbuildings, installing weather proof receptacles, improved safety lighting and water fountains. Phase I of the Master Plan calls for the installation of 3 – 5 frost free units strategically placed near key park features. Less capital intensive items include adding more benches, fitness trail, trail improvements, rain garden and installing horseshoe pits. A partial grant was provided by Clermont County for a rain garden to control stormwater run-off and a local Girl Scout troop has agreed to provide labor for the project, but fund are needed for all the materials needed to finish the garden. Park signage is needed and a top notch team is needed to get the main walking trail in shape.
