Update on Community Development Block Grant (CDBG) for Tornado Sirens

Fire Chief Pegram gave an update on the sirens. The grant was denied as presented. The Commissioners called a meeting to ask for bids, but the County already has the system and could only use specific vendor. There will be two installed by June 1, 2013. The exact location is being reviewed.

Fire Chief Pegram is asked for the Boards approval to look for funding for a generator. There will be a need for 12.5% matching funds if the grant is awarded. Trustee Corcoran asked if the funds are there if approved. Chief Pegram stated that we should be able to cover when that comes through. Expects the cost to be \$6,000 to \$7,000.

He asked for an update on public records requests. He asked about the healthcare maximum payout and where Officer Taylor moved to.

Mark Penn, Goshen Ohio – Acknowledged that losing Officer Taylor is a big loss. He is thankful for Officer Wolf, but is concerned why we are hiring when we are laying off part-time Fire and EMS personnel. He questioned salary employees receiving the benefits of the union employees. Trustee Hausermann stated we are trying to keep the current staff and ask Police Chief Snyder what dictates a salaried employee. Police Chief Snyder stated the Fair Labor Standards Act defines an employee as exempt or non-exempt. He sent the job description to the labor attorney and they stated that the Police Captain job description is non-exempt. The Board will review the proposed wage changes at future meetings. Trustee Autenrieb stated that we didn't hire extra officers, but we replaced.
