### **Park Board Update**

He stated if they are not notified he will start a petition and it will be put on the ballot.

Steve Holland – Goshen – Mr. Holland congratulated Lois and Lisa. Mr. Holland stated he has a problem with asking for more money when there is an investigation going on for

missing money. People need to know where the money is going. There was 1.2 million in the General Fund when Hausermann and Autenrieb took office, what happened to it?

Victoria McCully – Lakeshore MHP- Ms. McCully stated she attended the school board meeting and wanted to show her appreciation for them having a community forum. The short cut to Kroger is very slippery and asked that something be done to make it not so dangerous.

Jack Carey – Motor King – Mr. Carey stated that by the Township hurting Motor King they hurt the township as a whole. It brought sales down which means less taxes to Goshen. Mr. Carey asked Bob Hausermann if when he was on the Zoning Commission had he ever called a business owner. Bob stated no. Mr. Carey stated that Tom Risk did not go thru the proper channels and should be held accountable. He asked that Kathie Alley be removed and let Goshen grow.
