256-2013 Trustee Autenrieb motioned to adopt the agenda. Trustee Hausermann seconds the motion; motion carries.

Communication and Announcement

Administrator Snyder announced the Tire Amnesty Day sponsored by the Township Trustees and the County Commissioners which will be held on November 14, 15 and 16th from 9AM to 4PM at the Shelia Green School Grounds.

New Business

258-2013 Trustee Autenrieb motioned to approve the payment of bills. Trustee Hausermann seconds the motion; motion carries.

Trustee Hausermann – Yes Trustee Autenrieb – Yes Trustee Corcoran – No, I have not reviewed them as of yet.

Old Business

Trustee Hausermann asked for an update to the township salt bin.

Service Director Seyfried stated that the project is complete and it came to a total cost of \$26,558.40 which includes labor plus cost. The past bids have been \$120K plus, so we did good by erecting it ourselves and saved around \$93K.

Park Board Update

George Jones stated there will be a Festival of Lights that will start after the parade. This will run from the time of the parade thru the first of the year. It will be complete with computerized music.

Community Forum

Trustee Hausermann stated that anyone can speak during the community forum but being derogatory towards anyone person will not be tolerated.

Jack Carey – Asked Trustee Hausermann if his family was in fact the ones who built the building at 1601 SR 28. Trustee Hausermann stated yes in 1963. Mr. Carey stated his apology to Ray Snyder and thanked him for helping apprehend the suspect who took one of his signs down over the week end. It was Ray's brother Michael Snyder. Mr. Carey wanted to know what the difference was between Michael Snyder taking down a sign and ODOT taking down his wall without permission. Mr. Carey stated he was not treated the same as other owners of township business. Mr. Carey addressed Trustee Corcoran and stated he had her questions in writing and would give them to her.

Jim Constable – Fayetteville, OH – talked about Goshen's financial problems. Mr. Constable stated it would help if everyone would pay up their back taxes, if we reallocate rest of the tiffs, and if we put on a levy using correct figures.

Janice Walker – West Curt Ln – Janice felt Jack Carey was a targeted business. All the bad publicity, negative campaigning was created by the township. We all need to work together. Janice gave Ray and Bobby both credit for not slinging mud with everyone else.

Bob Saylor - CPAAA President – He spoke about the Christmas Shop with a Police Officer. Last year they were able to help 8 Goshen children and hope to help more this year. We have a 32" TV that is being raffled off at the Holly Fair at 2PM. You can get tickets at Kroger on November 3rd and 17th. You can make a donation by dropping off a

check at the police department payable to Goshen CPAAA for Christmas Shopping with a Police Officer.

Steve Holland – Goshen – Mr. Holland stated that Jack Carey should be done with the township. It was a State problem with the right of way and he should take it up with them. Mr. Holland stated it was good that the Service Department saved money by doing the salt bin themselves. Mr. Holland stated that he was a victim of a squad run this past week and the squad had no heat. These things needs fixed. I resigned from the Zoning Board because it was all against what I stand for. Things need to change and do things right.

Donnie Combs – Goshen – Mr. Combs backs Jack Carey about Ray Snyder and Claire Corcoran stepping down. He stated the township needs to get their act together and figure out what they are doing.

Ken Klosterman – Loveland – Stated the Goshen Township Life Squad carried him down three flights of stairs and he would like to donate \$500.00 to the Goshen Township Life Squad.

Lisa Allen – Goshen – Ms. Allen stated that if anyone had any questions in reference to budget or numbers they can give her a call anytime.


