Mr. Constable inquired if the Service Department had verified with the County if the salt purchase could be done without a closed bid process; Service Director Seyfried replied that Administrator Snyder had confirmed a purchase can be made up to \$50,000.00 without going into a closed bid process. Mr. Constable spoke about prior meetings conducted by the GCDC and questioned the \$12,000.00 owed for back taxes on the GCDC properties.

Victoria McCulley - Goshen, OH

Ms. McCulley inquired if the 3 Trustee's salary are the same each month and inquired how many hours the Trustees spend monthly on Township business; Trustee Allen replied the state dictates the salary of a Trustee and this is based on Township's budget and that hours are not mandated by the state. Fiscal Officer Allgeyer stated the current salary for each Trustee is \$1,028.00 per month. Ms. McCulley inquired if a short cut could be installed for Lakeshore at the expense of the Township; Service Director Seyfried replied that the property was owned by the state and the Township could not put a short cut in. Ms. McCulley discussed making plans for the community homeless in the coming months.

Mr. Corcoran inquired about the 2015 budget amounts for Lighting Assessment Fund; Fiscal Officer Allgeyer replied she would confirm the amounts and respond via email to Mr. Corcoran.

Mr. Holland requested a status in the Police evidence room investigation; Trustee Corcoran directed Mr. Holland to the BCI report filed which is public record which he could request from the Police Department and stated that Clermont County is currently investigating with the assistance from the Hamilton County Sheriff's office.

# Department(s) financial and project status

Chief Pegram presented Fire and EMS department's update for 2014 budget and projects; update is attached for reference. Trustee Corcoran stated she would like for at least one Trustee to be present when hiring for full time Fire / EMS positions. Trustee Swift inquired if the Fire Department charges for business fire inspections; Chief Pegram replied we do not currently charge due to several reasons, one being that fire inspections are not required for all businesses. Chief Pegram stated he had previously worked in a community were fire inspections were charged and the community perception was not good regarding charging.
