Administrator Ethridge stated he was continuing to search for additional members for the Zoning Commission and Board of Zoning Appeals in order to fill vacancies. Administrator Ethridge stated the Community Press paper had run an article regarding the vacant positions and stated that he had hand-outs at tonight's meeting for anyone interested in the positions.

Administrator Ethridge stated that the Board of Trustees had approved the 2015 budget on March 16, 2015. Administrator Ethridge stated the philosophy of the 2015 operational budget was a conservative approach and stated the revenue amount the County had allocated to Goshen Township was \$5.4 million. Administrator Ethridge stated that the philosophy he has chosen as the Township Administrator and his recommendation is a very conservative approach to the operational budget process, which the Board of Trustees adopted at the March 16, 2015 meeting. Administrator Ethridge stated he believes you should be conservative to allow for a rainy day fund or for capital equipment purchases. Administrator Ethridge stated at the beginning of 2015 there was \$1.9 million in unencumbered funds available and that it would only take one natural disaster and that the Township needs funds available for an emergency situation. Administrator Ethridge stated that the next phase of the budget process is to plan over the next five years for capital equipment purchases.

Administrator Ethridge stated he had looked at surrounding municipalities for resolution language and had presented a draft for review to the County Prosecutor's office for a document which could be presented to the Board of Trustees.

Administrator Ethridge read into the record activities "Not" prohibited by this resolution. A copy of the resolution is attached for reference. Administrator Ethridge stated the six items read would allow the Girl or Boy Scouts to come door to door but this resolution is to prohibit individuals selling door to door for future goods. Trustee Corcoran stated that individuals had called because citizens had complained about individuals in neighborhoods selling products. Chief Combs stated he had also received complaints and also recommended the Board to pass the resolution.

Clermont County Chamber of Commerce membership

Administrator Ethridge stated he believes it is a good idea to have a strong relationship with Clermont County by becoming a member of the Clermont County Chamber of Commerce and that the annual membership cost is \$800.00, but that he is still negotiating the membership cost. Trustee Corcoran recommended the motion be tabled until the final membership price is determined. Board of Trustees agreed; motion was tabled.

Old Business

Mr. Joe Spaulding presented the Park Board update and a copy is attached for reference.

Trustee Allen read into the record an email received by Chief Combs regarding Parker Road and St. Rt. 132 intersection, with possible guardrail installation and for further analysis to be done by the State. Chief Combs stated he has driven around the community to evaluate safety of the roads and had sent a letter regarding the safety of the Parker Road and St. Rt. 132 intersection, due to the depth of the ditch and if the ditch fills with water that both Police Chief Combs and Fire / EMS Chief Pegram have deemed this a hazardous area. Fire / EMS Chief Pegram stated if an accident happens at this intersection in wet conditions that the ditch when flooded can hold seven to eight feet of water and could make recovery difficult. Trustee Swift inquired if the property owners at this intersection had been asked regarding the installation of guardrails; Police Chief Combs stated the property owners do not have the right of way and that this particular ditch could submerge a car. Chief Combs stated the State is aware of the problem because they have installed extended signs in order to be seen. Trustee Corcoran stated this issue has been presented before and the State installed the current white reflective polls. Chief Combs stated this area is a State route and is the States responsibility and not the Counties. Chief Combs stated that he believes this is one of the most dangerous intersections he has seen. Trustee Corcoran stated that water in the ditch is also affecting the current road way.

Community Forum

Andrew Evans - Goshen, OH

Mr. Evans stated he was representing the Goshen Chamber of Commerce and that he is the current Chamber President. Mr. Evans stated that the Goshen Chamber of Commerce had been asked to take over the management of the Goshen Memorial Day Parade and he requested that the Board of Trustees to make an official vote for the Goshen Chamber of Commerce to officially manage the Goshen Memorial Day Parade. Mr. Evans stated the parade would be held on Monday, May 25 and asked for continued support from the Township. Mr. Evans inquired of the Board of Trustees if they would require him to come before the Board for speakers and grand marshal approval; Chief Combs recommended to Mr. Evans that he should notify the Board of Trustees of the individuals they are recommending to speak and for the grand marshal. The Board of Trustees requested that the Chamber email the

Trustees of the individuals the Chamber recommends. Trustee Corcoran stated she would like for Fire / EMS Chief Pegram to continue the tradition of laying flowers on a grave; Chief Pegram stated the flowers are laid on the grave of a fallen firefighter. Trustee Corcoran stated that the Chamber should work with Police Chief Combs regarding street closures during the parade. Mr. Evans stated that the annual membership dues for the Goshen Chamber of Commerce were significantly less than the dues for the Clermont County Chamber and requested the Board of Trustees consider joining the local Chamber before becoming a member of another Chamber.
