- **Article 12 Sign Code:** Case 234, After further discussion, it was noted that Lou Ethridge will get further legal opinions on this subject. On May 27, 2008 at 5:00 pm, the Clermont County Planning Commission will be hearing this case to vote and forward back to this committee to set the public hearing for the Township Trustees.

- **Amendments to Fences, Walls and Hedges Resolution:** After in depth discussion on the recommended amendments a motion was put forth to make the said changes. Motion made by Elben Miller to accept the recommended amendments with the following additional amendments: D5 On chain link fences the open end fence must be toward the ground.

Section A second paragraph has been deleted, Section B 3 has been deleted, C1 has been deleted. Under D 1 add materials used for fences shall be of a traditional fence material. Also Under D5 add that chain link fences shall have the open end installed facing down toward the ground. Section F the dollar amount will be eliminated. Second by Bob Hausermann.

Lou Ethridge will have in writing by Friday what is needed to get started with the planned development.

With a show of hands the work shops throughout the summer will not be canceled. Bob Seyfried asked if a secretary must be present.....response is yes every time 2 or more board members are present it is a public meeting and minutes must be taken.

• **B2 Parking Lots:**

Discussion on parking lots in the business district as to setting regulations on new businesses to have paved lots in adverse to gravel. Speaking on the ERS Auto Sales.....which has moved from one side of the street to the other which was a residential home and now is a car lot. Lou Ethridge stated they have not been in with a site plan as of yet. The board asked that Lou get with the Clermont County Building Department and see what the regulations are for this type of business, to make sure we are not contradicting anything on this issue. This is a change of usage in the property from residential to business.
