NOTICE TO BIDDERS

2010 Sewer Repairs
Sites #9, #10, #11, & #12

Separate sealed bids for sewer repairs to Sites #9, #10, #11 & #12 will be received by the City Clerk in the City Hall, Granite City, Illinois 62040 until 10:30 a.m., Wednesday, June 30, 2010, at which time the bids will be publicly opened and read aloud. Sealed bids should be labeled "2010 Sewer Repairs-Sites #9, #10, #11 & #12" on the outside of the envelope.

The proposed work consists of the following:

Site #9 – Olive Street

Cleaning and televising of the existing 12" line as well as installation of 12" cured in place pipe liner from M.H. #11 to M.H. #12. Surface restoration of the site is also included in the repair.

Site #10 – 1700 Block between Edison & State

Cleaning and televising of the existing 54" storm sewer from M.H. #231 to M.H. #232.

Pressure grouting of the existing 54" storm sewer as needed according to video inspection. Surface restoration of the site is also included in the repair.

Site #11 – Alley at Poplar

Cleaning and televising of the existing 18" line as well as the installation of 18" cured in place pipe liner from M.H. #5 to M.H. #7. Surface restoration of the site is also included in the repair.

Site #12 – Alley at Spruce

Cleaning and televising of the existing 18" line as well as the installation of 18" cured in place pipe liner from M.H. #5 to M.H. #7. Surface restoration of the site is also included in the repair.

The successful bidder will be required to agree that not less than the prevailing rate of wages as determined by the Secretary of Labor and made a part of these contract documents shall be paid to all laborers, workmen and mechanics performing their work under this contract.

The City of Granite City reserves the right to waive, or not to waive, any irregularities in the bids and to reject any or all bids and to determine which is the lowest and best bid.
