

The regular meeting of the Green Township Board of Trustees held on February 24, 2025 was called to order at 5:30 p.m. with the Pledge of Allegiance.

Roll Call: Trustee Rosiello, present; Trustee Linnenberg, present; Chairman Callos, present; Fiscal Officer Straus, present.

Chairman Callos moved to approve the minutes for the regular meeting of February 10, 2025. Trustee Linnenberg seconded the motion. All voted Yes.

RESOLUTION #25-0224-A

Chairman Callos moved to accept and approve the financial reports as submitted. Trustee Linnenberg seconded the motion. The resolution passed unanimously.

RESOLUTION #25-0224-B

Chairman Callos moved to accept and approve the Amended Estimated Resources for 2025. Trustee Linnenberg seconded the motion. The resolution passed unanimously.

Chairman Callos moved to accept and approve the Amended Appropriations for 2025. Trustee Linnenberg seconded the motion. The resolution passed unanimously.

Chairman Callos moved to approve the promotion of Rob Crone to Assistant Chief of Fire & EMS with a salary of \$57.45 per hour and effective February 24, 2025. Trustee Linnenberg seconded the motion. The resolution passed unanimously.

RESOLUTION #25-0224-E

Chairman Callos moved to approve the hiring of Lindsey Helmers as Director of Finance with a salary of \$55.25 per hour and effective February 24, 2025. Trustee Linnenberg seconded the motion. The resolution passed unanimously.

RESOLUTION #25-0224-F

costs as needed. Trustee Linnenberg seconded the motion. The resolution passed unanimously.
