RULES AND REGULATIONS

1. Park shall be open to the general public between the hours of 7:00 a.m. to dark.
2. No person shall drive, propel, or park any motor vehicle, mini bike, motorcycle, or other motorized vehicle on any unpaved portion of the Park. Parking is permitted only in the designated parking areas. Overnight parking is not permitted.
3. Speed limit shall be five (5) MPH on Park roads.
4. Horses, unleashed dogs, and other pets are prohibited in the Park. Dogs on a leash are permitted provided the owners assume responsibility for picking up and disposing of their dog's excrement.
5. No person shall injure, deface, disturb, or befoul any part of the Park nor any building, sign, equipment, or other property found therein; no trees, flowers, shrubs, rock or other minerals shall be removed, injured or destroyed.
6. No hunting or molesting of wildlife is permitted within the Park.
7. Only small cooking fires are permitted. They must be in grills and shall be completely extinguished before persons leave the area.
8. Cans and all other waste materials must be placed in trash containers.

PERSONS WHO HAVE RESERVED AND USED THE SHELTERHOUSE MUST, BEFORE LEAVING, REMOVE AND TIE ALL PLASTIC TRASH BAGS. EXTRA PLASTIC BAGS WILL BE STORED IN THE BOTTOM OF THE TRASH CONTAINERS. PLEASE OPEN UP A BAG AND PLACE IT INSIDE THE CAN FOR THE NEXT USERS. BAGS MUST BE PLACED INTO CONCRETE BLOCK TRASH CONTAINER LOCATED BEHIND THE RESTROOM BUILDING

9. No glass bottles may be brought into the park.
10. No golf practicing is permitted.
11. No person shall sell or offer for sale any article, thing, privilege or service within the Park without a permit from the Board; no person shall do any begging, hawking, peddling or soliciting therein.

12. **Alcoholic beverages (including beer in cans and bottles) are prohibited at all times. Non-alcoholic beverages in glass containers are also prohibited. Within the confines of a Park Shelterhouse and upon the issuance of a license, beer in cans or kegs is permissible.** Permission granted by the Board of Trustees does not constitute a temporary permit from the Ohio Department of Liquor Control. State of Ohio requirements for liquor permits are the responsibility of the individual or organization hosting the event.
13. No person shall, either by word or act, indulge in any noisy, boisterous, disorderly or indecent conduct, or in any manner disturb the peace or good order of the community within the Park; no person shall play at games of chance, or be drunk, or do any indecent, lascivious, lewd, or improper act therein.
14. No person shall obstruct, resist, or be abusive of or use profanity to a Police Officer or authorized agent of the Township in and during the lawful discharge of his/her duties.
15. No person shall remain within the Park who does not abide by conditions adopted and posted by the Township for the preservation of good order and protection of property within the Park; no person shall remain within the park who does not abide by the instructions and directions of duly authorized officers or agents of the Township in the lawful performance of their duties. Any person directed by a Police Officer or agent of the Township to leave the Park shall do so promptly and peaceably.
16. Athletic fields may be closed when conditions warrant.
17. Athletic Fields are available to the public except when a permit is issued. If a permit for use of the field is desired, contact Butch Nanney, Assistant Director of Public Services, at 574-8832 for information.
 - Blue Rock Park & Bosken Park Athletic Fields: Hardball by persons over the age of 12 is prohibited.
18. The Park Shelterhouse may be reserved. Licenses are issued through the Township. Contact the Green Township Department of Public Services at 574-8832 for the appropriate details.

The Green Township Board of Trustees adopts these rules and regulations pursuant to Sections 511.32 and 755.13 of the Ohio Revised Code.

Penalty Fine of not more than One Hundred Dollars (\$100) for the first offense and Five Hundred Dollars (\$500) for each subsequent offense.

By the order of the Green Township Board of Trustees and under the supervision of the Township Administrator pursuant to O. R. C. Section 505.032, Resolution #97-1222-S entered in the journal of said board.

SHELTERHOUSE RENTAL INFORMATION

TO RENT A SHELTER YOU MUST BE A RESIDENT OF GREEN TOWNSHIP.

Rental includes shelter and grills only; the rest of the park is open to the public with the exception of Bosken Park. Persons who have reserved the shelterhouse at Bosken Park have exclusive use of all park facilities except the handicapped swing which shall remain available to the public and the athletic field if a permit has been issued.

1. Rental time is 7:00 a.m. until Dark or longer at Trustees/Director of Public Services discretion.
2. The Green Township Board of Trustees reserves the right to cancel the rental agreement for a picnic shelter if such action is deemed to be in the best interest of Green Township. Such action must take place one month prior to the date reserved. The Board of Trustees further reserves the right to cancel a rental agreement at any time in the event of Acts of God or emergencies that are beyond the control of the Board of Trustees. A full refund of all rental fees will also be made.
3. Charges: \$75 Shelter Rental *without* Beer Permit
 \$85 Shelter Rental *with* Beer Permit

The following items must be completed to be eligible for future Green Township Park Rentals:

1. Restrooms straightened.
 2. Shelter area cleaned up.
 3. Garbage bags have been tied up, put in the designated area, and clean bags pulled up from the bottom of the cans for the next users. (See Paragraph 8 in the Rules and Regulations.)
 4. No damage to the premises.
4. Cancellation: Will forfeit your \$75/\$85 park rental fee.
 5. The rentee must keep the license and the rest of the packet with them at the rental site as proof that they have paid for use of the shelterhouse and are entitled to sole use of the shelter for that day.
 6. Ballfield: There is no charge to reserve a field, if available. The field permit will be included with the rental packet.
 7. It is advisable to bring a broom and dustpan, extra toilet tissue and paper towels for your own convenience.
 8. For your convenience we have a sign available for your use, which can be posted on the side of the shelterhouse stating your name, the date and time of your event. You may pick this up several days before your rental and return the sign to us after your event. The sign is NOT required.
 9. **Alcoholic beverages (including beer in cans and bottles) are prohibited at all times. Non-alcoholic beverages in glass containers are also prohibited. Within the confines of a Park Shelter House and upon the issuance of a license, beer in cans or kegs is permissible.** Permission granted by the Board of Trustees does not constitute a temporary permit from the Ohio Department of Liquor Control. State of Ohio requirements for liquor permits are the responsibility of the individual or organization hosting the event.
