REQUEST FOR BIDS/PROPOSALS: TERMS AND CONDITIONS

1. **AUTHORITY** This Request for Bids/Proposals is issued pursuant to applicable provisions of the Kenton County Purchasing Ordinance.
2. **BID/PROPOSAL OPENING** Sealed bids/proposals will be received at the Kenton County Purchasing Department until the date and time specified, at which time they shall be opened in public. Late bids/proposals shall be rejected and returned unopened to the sender. Kenton County does not prescribe the method by which bids/proposals are to be transmitted; therefore, it cannot be held responsible for any delay, regardless of the reason, in transmission of the bids/proposals. **Facsimile bids/proposals will not be accepted.**
3. **BID/PROPOSAL PREPARATION** Bids/Proposals must be submitted on the bid/proposal form when provided and all information and certifications called for must be furnished. Bids/Proposals submitted in any other manner, or which fail to furnish all information or certificates required, may be summarily rejected. Bids may be modified or withdrawn prior to the time specified for the opening of bids/proposals. Bids/Proposals shall be filled out legibly in ink or typewritten with all erasures, strikeovers and corrections initialed in ink by the person signing the bid. The bid shall include the legal name of the bidder, the complete mailing address, and be signed in blue ink by a person or persons legally authorized to bind the bidder/offeror to a contract. Name of person signing should be typed or printed below the signature.
4. **BID/PROPOSAL ENVELOPES** Envelopes containing bids/proposals must be sealed and addressed to the Kenton County Purchasing Department. The title of the bid/proposal as specified in the RFB/RFP document must be shown on the outside of the envelope.
5. **ERRORS IN BIDS/PROPOSALS** Bidders/Offerors are cautioned to verify their bids/proposals before submission. Negligence on the part of the bidder/offeror in preparing the bid/proposal confers no right for withdrawal or modification of the bid/proposal after it has been opened. In case of error in the extension of prices in the bid/proposal, the unit prices will govern. All price extensions are to be checked by the buyer to insure the total bid/proposal is accurate.
6. **RESERVED RIGHTS** Kenton County reserves the right at any time and for any reason to cancel this Request for Bids/Proposals, accept or reject any or all bids/proposals or any portion thereof, or to accept an alternate bid/proposal. Kenton County reserves the right to waive any immaterial defect in any bid. Kenton County may seek clarification from any bidder/offeror at any time and failure to respond promptly is cause for rejection.
7. **INCURRED COSTS** Kenton County will not be liable for any costs incurred by bidders/offers in replying to this Request for Bids/Proposals.
8. **AWARD** It is the intent of Kenton County to award a contract to the lowest responsible bidder/offeror meeting specifications. Kenton County reserves the right to determine the lowest responsible bid/offer on the basis of an individual item, groups of items, or in any way determined to be in the best interests of Kenton County. Award will be based on the following factors (where applicable): (a) adherence to all conditions and requirements of the bid/proposal specifications; (b) price; (c) qualifications of the bidder/offeror, including past performance, financial responsibility, general reputation, experience, service capabilities, and facilities; (d) delivery or completion date; (e) product appearance, workmanship, finish, taste, feel, overall quality, and results of product testing; (f) maintenance costs and warranty provisions; and (g) repurchase or residual value. Bids/proposals accepted by the Kenton County Fiscal Court will be available to all members of the Northern Kentucky Governmental Purchasing Association.

9. **PRICING** The price quoted for each item is the full purchase price, including delivery to destination, and includes all transportation and handling charges, premiums on bonds, material or service costs, patent royalties and all other overhead charges of every kind and nature. Unless otherwise specified, prices shall remain firm for the contract period.
10. **DISCOUNTS** Prices quoted must be net after deducing all trade and quantity discounts. Where cash discounts for prompt payment are offered, the discount period shall begin with the date of receipt of a correct invoice or receipt or final acceptance of goods, whichever is later.
11. **OCCUPATIONAL LICENSES** All Bidders/Offerors must have or obtain a Kenton County and Cities Occupational License prior to performing any work in Kenton County or any of its Cities, Kenton County Ordinance 225.19, Section III (a). Bidders/Offerors must be in full compliance with all Kenton County and Cities' Occupational License Ordinances (KENTON COUNTY FISCAL COURT ORDINANCES 78-6-1, 220.8, 223.0, 223.7, 225.19, 225.25) prior to awarding of a contract. Kenton County shall have the right to reject any bids/offers from Bidders/Offerors that are not in compliance with Kenton County and Cities' Occupational License Ordinances.
12. **TAXES** Kenton County is not subject to Federal Excise tax. Per Kentucky Administrative Regulation 103 KAR 30:225E, Kenton County is exempt from state and local taxes.
13. **SPECIFICATIONS** Reference to brand names and numbers is descriptive, but not restrictive, unless otherwise specified. Bids/Proposals on equivalent items will be considered, provided the bidder/offeror clearly states exactly what is proposed to be furnished, including complete specifications. Unless the bidder/offeror specified otherwise, it is understood the bidder/offeror is offering a referenced brand item as specified or is bidding/offering as specified when no referenced, and does not propose to furnish an "equal." Kenton County reserves the right to determine whether a substitute offer is equivalent to and meets the standard of quality indicated by the brand name and number.
14. **SAMPLES** Samples of items, when called for, must be furnished free of expense and, if not destroyed in the evaluation process, will, upon request, be returned at the vendor's expense. Request for the return of samples must accompany the sample and include UPS Pickup Slip, postage or other acceptable mode of return. Individual samples must be labeled with bidder/offeror's name, item reference, manufacturer's brand name and number.
15. **INTERPRETATION OR CORRECTION OF BIDDING DOCUMENTS** Bidder/Offerors shall promptly notify Kenton County of any ambiguity, inconsistency or error which they may discover upon examination of the bidding documents. Interpretations, corrections and changes will be made by addendum. Each bidder/offeror shall ascertain prior to submitting a bid that all addenda have been received and acknowledged in the bid.
16. **VARIANCES** State or list by reference on the reverse side of the Bid/Proposal form herein any variations to specifications, terms and/or conditions.
17. **INDEMNIFICATION** The Seller shall indemnify and hold harmless Kenton County, its agents, officials, and employees from and against all injuries, losses, claims, suits, costs and expenses which may accrue against Kenton County as a consequence of granting the Contract.
18. **DEFAULT** Time is of the essence of this contract and if delivery of acceptable items or rendering of services is not completed by the time promised, Kenton County reserves the right, without liability, in addition to its other rights and remedies, to terminate the contract by notice effective when received by Seller, as to stated items not yet shipped or services not yet rendered and to purchase substitute items or services elsewhere and charge the Seller with any or all losses incurred. Kenton County shall be entitled to recover its attorney's fees and expenses in any successful action by Kenton County to enforce this contract.

19. **INSPECTION** Materials or equipment purchased are subject to inspection and approval at Kenton County's destination. Kenton County reserves the right to reject and refuse acceptance of items which are not in accordance with the instructions, specifications, drawings or data of Seller's warranty (express or implied). Rejected materials or equipment shall be removed by, or at the expense of, the seller promptly after rejection.
20. **WARRANTY** Seller warrants that all goods and services furnished hereunder will conform in all respects to the terms of this solicitation, including any drawings, specifications or standards incorporated herein, and that they will be free from latent and patent defects in materials, workmanship and title, and will be free from such defects in design. In addition, Seller warrants that said goods and services are suitable for, and will perform in accordance with, the purposes for which they are purchased, fabricated, manufactured and designed or for such other purposes as are expressly specified in this solicitation. Kenton County may return any nonconforming or defective items to the Seller or require correction or replacement of the item at the time the defect is discovered, all at the Seller's risk and expense. Acceptance shall not relieve the Seller of its responsibility.
21. **REGULATORY COMPLIANCE** Seller represents and warrants that the goods or services furnished hereunder (including all labels, packages and container for said goods) comply with all applicable standards, rules and regulations in effect under the requirements of all Federal, State and local laws, rules and regulations as applicable, including the Occupational Safety and Health Act as amended, with respect to design, construction, manufacture or use for their intended purpose of said goods or services. Seller shall furnish "Material Safety Data Sheets" on all chemicals.
22. **EQUAL EMPLOYMENT OPPORTUNITY** Contractor shall comply with the Kentucky Human Rights Act, HRA 344.150 – 344.270 as amended and any rules and regulations promulgated in accordance therewith, including, but not limited to the Equal Employment Opportunity EEO 45.550 – 45.640 which is incorporated herein by reference. Furthermore, the Contractor shall comply with the Employment Discrimination Act, EDA 344.040, 344.050 as amended.
23. **ROYALTIES AND PATENTS** Seller shall pay all royalties and license fees. Seller shall defend all suits or claims for infringement of any patent, copyright or trademark rights and shall hold Kenton County harmless from loss on account thereof.
24. **LAW GOVERNING** This contract shall be governed by and construed according to the laws of the Commonwealth of Kentucky. Pursuant to the provisions of KRS 45A.343, the contractor or vendor is required to reveal to Kenton County any final determination of a violation of KRS Chapters 136, 139, 141, 337, 338 and 342 by the contractor or vendor within the previous five (5) years; and further that said contractor or vendor has been and is in continuous compliance with the provisions of KRS Chapters 136, 139, 141, 337, 341, and 342 for the duration of the contract. The failure of a contractor or vendor to reveal a final determination of a violation to a local government, or to comply with the statutory requirements, is considered grounds for cancellation of a contract and disqualification of the contractor or vendor from eligibility for any Kenton County contracts for a period of two (2) years.

1.0 SCOPE

It is the intent of these specifications to describe uniforms and associated equipment for Kenton County Detention Center and the Kenton County Police Department in sufficient detail to obtain bids on comparable uniforms.

While the purpose of this specification is to indicate certain minimum requirements, it is not the intent to exclude any bids, but is written to ensure Kenton County Detention Center and Kenton County Police Department a type of uniform most suitable for its requirements.

The Kenton County Fiscal Court or designee(s) must be permitted to inspect the Contractor's business premises if deemed necessary by the County as a part of the bid evaluation.

The Kenton County Detention Center and the Kenton County Police Department reserves the right to add or discontinue any item as they see fit for their department.

All specifications shall be followed as written without deviation except as noted herein.

2.0 CONTRACT LENGTH

The contract period will be for a period of two (2) years from the date that this Contract is executed. The Contract may be extended for three one (1) year periods upon a request by the Contractor and with the approval of the Kenton County Fiscal Court. If the Contractor desires to extend the Contract and to change prices, the request for extension and any price changes must be submitted to the County in writing for analysis and recommendation to the Court thirty (30) days prior to the expiration of the contract. Either the Bidder or the County may cancel this bid with a thirty (30) day written notice.

3.0 ORDERING

The Kenton County Detention Center and the Kenton County Police Department requires a secure online ordering system that is only accessible by users defined and approved by us with unique user names and passwords. The system must also be configurable based on the Kenton County Detention Centers and the Kenton County Police Department uniform requirements where the uniform profile defines the operating parameters in which the system will govern the program, to include: employee management, allotment management, product offering, delivery requirements and invoicing.

4.0 PACKAGING

All items ordered for an individual must be packaged by the Contractor for delivery and that individual's name shall be clearly marked on the outside of the package. No bulk packaging of any items will be permitted.

5.0 EMBLEMS AND PATCHES

Whenever required in the detailed specifications, emblems, patches, and required must be affixed by the Contractor as prescribed in the Specifications prior to delivery of the items.

6.0 FREIGHT

All price quotes shall be submitted with freight costs included.

7.0 DELIVERY

Delivery must be made to designated department (Kenton County Detention Center or Kenton County Police Department) within thirty (30) days of actual order.

8.0 INVOICES/PAYMENTS

No state use taxes are applicable. Payments will be thirty (30) days net.

9.0 SAMPLES

Samples must be submitted of each of the uniforms and accessory items with your unit bid prices on this bid. Vendors will be notified of availability for pickup after the County has finished the evaluation. Failure to submit samples could be cause for rejection of your bid.

Substitutions for items specified herein are permitted with samples and manufacturer's specifications unless, specified otherwise. Your bid may not be considered unless this requirement is met in full and to the satisfaction of the County.

10.0 MEASUREMENTS

All measurements must be taken at the Kenton County Detention Center and Kenton County Police Department on three (3) consecutive days at the convenience of the Detention Center and Police Department personnel. The vendor must maintain a record of individual uniform sizes of each officer. The vendor will be required to take measurements as needed at the Detention Center and Police Department to accommodate changes in sizes. The vendor must also maintain an inventory of these sizes for purchase throughout the contract period.

Any misfits due to the Contractor's error(s) in measuring, or failure to take measurements, are the Contractor's responsibility and should misfits occur, same shall be replaced with the proper fit within a reasonable period.

11.0 BID NOTICE

Pursuant to the provisions of KRS 45A.343, the contractor or vendor is required to reveal to the County any final determination of violation of KRS Chapters 136, 139, 141, 337, 338 and 342 by the contractor or vendor within the previous five (5) years; and further that said contractor or vendor has been and is in continuous compliance with the provisions of KRS Chapters 136, 139, 141, 337, 341 and 342 for the duration of the contract. The failure of a contractor or vendor to reveal a final determination of a violation to a local government, or to comply with the statutory requirements, is considered grounds for cancellation of a contract and disqualification of the contractor or vendor from eligibility for any County contracts for a period of two (2) years.

The bid/proposal selected by the County will be that which best satisfies the Specifications and the needs of the County. Items that may be used to evaluate and determine which bid/proposal is best are overall cost, delivery time, quality of previous work, and satisfaction of previous purchasers. The Kenton County Fiscal Court reserves the right to reject any and all proposals, to waive formalities, and to negotiate with the apparent qualified offeror to such an extent as may be determined by the Fiscal Court.

Bids accepted by the Kenton County Fiscal Court will be available to all members of the Northern Kentucky Governmental Purchasing Association.

Sealed Bids/Proposals are due in the office of the Purchasing Manager, 303 Court Street, Room 207, Covington, KY 41011 no later than 2:00 P.M on Thursday, May 16, 2019. Offerors shall submit an executed original of the Bid/Proposal Form and three (3) copies of all supporting documents. Bids/Proposals not so marked may be rejected at the discretion of the Fiscal Court. Facsimile proposals will not be accepted. Patches And Namestrips Must Not Penetrate Waterproof/Breathable Liner. This Will Be Cause For Rejection

ITEM #1 MEN'S LONG-SLEEVE SHIRT

- 100% textured polyester with Visa System 3
- 7.0-7.5 ounces/linear yard
- Black in color
- Dress style, top center placket front with zipper, full-cut tapered fit, banded collar, long sleeves with barrel cuff, dress shirttail.
- Two pleated breast pockets with top-stitched scalloped flaps, top-stitched shoulder straps and full badge reinforcement.
- Matching inside yoke and band of high luster PolyTwill.
- Work wear industrial style shirt construction is unacceptable and shall be cause for rejection.
- Collar points to measure 3-1/8" long with fused-in Mylar stays. Collar to have woven interlining of #250 Dacron. Stays to be 3" long, 3/8" minimum width, and to be fused to under side of collar interlining. Stays applied directly to collar material itself unacceptable. Collar height at rear 1-1/2". Collar topstitched 1/4" off the edge. Collar stand to measure 1-5/16" at rear and band to be interlined with "Crease-N-Tack." Collar material itself (top or underside) shall have no fusing to Mylar stays or collar interlining.
- The left front shall have a top center placket 1-1/2" wide with two rows of stitches 7/8" apart.
- Top center placket to have woven interlining of #250 Dacron. Non-woven interlining unacceptable and shall be cause for rejection.
- The fronts shall be joined to the yoke. Safety stitch joining unacceptable.
- A 15" nylon zipper, to be set below the second button and buttonhole, shall accomplish front closure. The top, second and bottom buttons to be attached to the right front, the balance to be sewn over the buttonholes on the left front.
- Shoulder straps to be two-piece pointed, 1/4" topstitched and to be set on yoke. Shoulder strap to have functional buttonhole to attach to sewn button on shoulder of shirt. Edge stitched shoulder strap construction unacceptable.
- Two-ply sling 1" wide centered over left pocket and stitched to shoulder seam and flap setting stitch. It shall have 2 (two) buttonhole eyelets 1-1/4" from top of pocket flap spaced 1-1/4" apart and centered on sling.

- Two breast patch pockets with mitered corners and 1-1/2" stitched pleats. Left breast pocket to have 1- 1/2" pencil stitch. Each pocket to have hook Velcro, 3/4" long by 1/2" wide, positioned on both edges of pocket to correspond with outer scalloped flap points as specified. Velcro to be stitched all sides and to be sewn through pocket and shirt for added reinforcement.
- Two piece deep scalloped design at center point, 2-1/4" at sides. Secured to shirtfront approximately 3/8" above pocket. Left flap to have invisible pencil opening 1-1/2" to correspond precisely with pencil slot of pocket. (Stop & start stitching for pencil opening unacceptable and shall be cause for rejection.) Flaps to be 1/4" topstitched. Flaps to have woven interlining of #250 Dacron. Creased and edge stitched pocket flap construction unacceptable. Under side of the flap to have looped Velcro 3/4" long by 1/2" wide stitched all sides, positioned on outer points of both pocket flaps to secure with corresponding Velcro strips on shirt pocket. Sleeve shall have a round one piece elbow reinforcement and vent facing. Lower facing shall measure approximately 1/2" wide.
- Two piece 1/2-inch hemmed cuff with 1/4" topstitching. Cuffs to measure 3" in depth with rounded corners (barrel cuffs). Cuffs to have two buttons and corresponding buttonholes set vertically with one button and buttonhole in center of facing. Cuffs to have woven interlining of #250 Dacron.
- Collar, shoulder straps, pocket flaps and cuffs to be topstitched 1/4" off the edge. Sleeve inserting and side close felling seams are to be safety stitched.
- All sewing threads to be color fast polyester wrap to match
