# **Economy showed** improvement in 2018

RUTHERFORDTON - Rutherford County's economy in 2018 continued to show improvement, with new companies moving in and historic low unemployment rates being recorded.

The dropping unemployment rate in Rutherford County is one of the big highlights for 2018," said County Manager Steve Gar-

rison. "The unemployment rate reached as low as 3.9 percent in September, which is the lowest it has been since December of 1998.

The year began with the announcement in January, of the establishment of Cardinal Tissue in Spindale. Vince Reece, a former executive with Clearwater Paper Company in Shelby formed the new company which

is primarily a "converter" in the tissue paper industry. The company takes large rolls of paper, and converts the paper into finished consumer paper products such as bath tissue and paper

Reece said he hopes to eventually have 50-100 full time employees.

## A look at Lake Lure in 2018

LAKE LURE — In 2018, Lake Lure made progress on infrastructure projects, created a master plan for Morse Park, survived the impacts of multiple large storms and filled numerous town positions. As 2019 begins, Mayor Kevin Cooley is expecting "another extraordinary year for our town."


'We appreciate all our citizens, those who visit our town and the awesome beauty that surrounds us in Lake Lure every day," Cooley added.

#### WEATHERING THE STORMS

Last year was a challenging one for Lake Lure. The town declared four states of emergency in 2018 to deal with storm recovery. Record rainfall caused mudslides and flooding that closed roads and required measures to manage lake levels and protect the dam.

A major winter storm dumped a foot of sleet and snow on Hickory Nut Gorge, making roads impassable and bringing down trees and utility lines. This delayed plowing until road blockages could be cleared. Power was knocked

out in the majority of homes and businesses for days. Following storms, the town dredged the lake to remove silt. Cooley said a new dredging contractor performed "exceptionally well."

Altogether, Cooley said Lake Lure "successfully weathered these events, learned from them and recovered well with the support of our citizens and our dedicated staff."

### **INFRASTRUCTURE** PROJECTS

During 2018, the Town of Lake Lure took steps forward on critical infrastructure projects including repair and rehabilitation of the dam and hydro-electric generating station. The dam was built in 1925-26 with the goal of creating the lake as the centerpiece of the community. The design included a strategy to maintain a consistent lake level to secure lakeshore property values and establish Lake Lure as a prime recreation destination. Another aspect of the original design was the addition of a hydro-electric plant. This allows the town to

(NCDEQ) Dam Safety Office requirements and to facilitate final design of any requisite repairs or improvements. Schnabel engineers supported the town's emergency response team during two major storm events in 2018, providing guidance on lakelevel management and flood gate control to protect the dam from damage, minimizing downriver flooding, whenever possible.

The town added an additional dam operator to strengthen staff capability and depth and to more efficiently operate the dam and maximize benefits of the hydroelectric plant.

Lake Lure also began work on a project to replace the existing inlake gravity sewage collection system. This land-based, low-pressure sewage collection system protects the environment. This project required by NCDEQ - will replace the sewage treatment plant with a modular-designed treatment plant. The town continues to work with Brown Consulting as wastewater engineers for this project. Cooley said that NCDEQ is reviewing the digital engineering report to find the most cost-effective solution to replace the cur-

consideration in the creation of the town's most recent budget. The new budget includes a tax increase to support continued operations and fund major capital improvement and enhancement projects.

"The town identified and pursued multiple opportunities to enhance supplemental income from the operation and use of town assets," said Cooley. "Better operational management of the hydroelectric station, focused on optimizing power generation, has resulted in the nearly doubling of power output/income. A new concession agreement was negotiated for

## **PLUNGING INTO 2019**

The town traditionally kicks off each New Year's Day with the Lake Lure Polar Plunge. The plunge had record numbers this year with 140 participants and more than 600 attendees. Folks dressed up in creative costumes and ran into the frigid waters of the lake to support local emergency ser-

As Cooley looks toward the future, he says Lake Lure is committed to critical infrastructure renewal and dam rehabilitation, sewage collection and treatment system replacement, and lake dredging.

The town hopes to renovate the commercial strip center, recruit additional businesses, begin replacing the existing boardwalk connecting the town marina to the beach so it can be incorporated into future designs, and develop a new Boys Camp Road Riverside Park and materials recovery facility. Lake Lure will also commence improvements to Morse Park.

Additionally, the town intends to hire recreational staff, improve cellular and broadband services, work towards an alternate entrance to Chimney Rock State Park and partner with Rumbling Bald Resort to move forward on a "connector road" to provide a quicker route between the resort and the town's commercial corridor and Chimney Rock Village, as well as to the Asheville-Hendersonville metropolitan areas. It would also provide an alternate ingress-egress route between the east and west sides of the Lake and allow faster access by first responders and replacement projects: emergency services.
