TO SECURE A USDA LOAN FOR DAM REPAIRS/RENOVATIONS

- WHEREAS, Consolidated Farm and Rural Development Act, as amended, Section 306, Public Law 92-419, 7 USC 1926, Executive Order Consolidated and Further Continuing Appropriations Act, 2013, Public Law 113-6 has established the United States Department of Agriculture (USDA) Community Facilities Loans and Grants Program, and has authorized the making of loans and grants to aid in constructing, enlarging, extending, or otherwise improving community facilities providing essential services to rural residents, and that the USDA Rural Development State and Area Offices were delegated the authority to administer the Community Facilities Loans and Grants Program received from the USDA program, and
- WHEREAS, The <u>Town of Lake Lure</u> has a need for and intends to <u>construct a dam renovation</u> project, and
- WHEREAS, The Town of Lake Lure has requested USDA assistance for the project,

NOW THEREFORE BE IT RESOLVED, BY THE COMMISSIONERS OF THE TOWN OF LAKE LURE:

That <u>Town of Lake Lure</u>, the **Grant Applicant**, will adopt and place into effect on or before completion of the project a schedule of fees and charges and other available funds which will provide adequate funds for proper operation, maintenance, and administration of the project.

That the **Grant Applicant** will provide for efficient operation and maintenance of the project on completion of construction thereof.

That <u>Shannon Baldwin</u>, <u>Town Manager and Kevin Cooley</u>, <u>Mayor</u>, both known as the <u>Authorized Official</u>, and successors so titled, are hereby authorized to execute the application and contract, with USDA for a grant and/or loan to aid in the construction of the project described above.

That the **Authorized Official**, and successors so titled, is hereby authorized and directed to furnish such information as the appropriate State agency may request in connection with such grant or the project; to make the assurances as contained above; and to execute such other documents as may be required in connection with the grant contract.

That the **Grant Applicant** has substantially complied or will substantially comply with all Federal, State, and local laws, rules, regulations, and ordinances applicable to the project and to Federal and State grants and loans pertaining thereto.
