General Meeting Actions:

- Chairperson Bo Williams called the meeting to order at 1:30 p.m.

- Camp Care: for the same reasons as in years past (insufficient capacity in the model for additional commercial ski boats and the applicant did not meet the minimum for a full season). Camp Care is not in the commercial model.

Wiley Bourne made a motion that the Lake Advisory Board accept the recommended approvals and denials as discussed and instruct Dean to present them to the Marine Commission.
