Other Business

Discussion Concerning a Request to Lower that Lake Early

Garland Prewitt, owner of property at 179 Tryon Bay Circle, presented a request asking for the lake to be lowered early this year to allow his contactor to do work on his property that was affected by a land slide last year.

Mr. Prewitt explained that he has been trying to get the project completed for months, but has been delayed multiple times.

Board members discussed the possibility of having the work completed without lowering the lake.

After further discussion, Bill Ashman made a motion to recommend that town council deny Mr. Prewitt's request and not lower the lake early. Dan Breneman seconded that motion. The board unanimously voted in favor of the motion.

Continue Discussion of Dredging Strategy

Board members discussed a 10-year dredging investment plan.

Joe Pritchett made a motion to recommend the following 10-year dredging investment plan for 2014-2024. Dan Breneman seconded the motion. The board unanimously voted in favor of the motion.

There are three components to the recommended annual dredging investment in Lake Lure:

- The River Channel: mouth of the broad river as it enters the mouth of Lake Lure.
 - It is estimated that 70% or more of the sediment entering the lake comes from the Rocky Broad River on the west side of the lake. The largest volume moves along the bed of the river and onto a plume of sediment that now reaches nearly a mile into the lake. Once it reaches this point, it is too deep to recover economically. The major thrust of the plan focuses on prevention/early capture of sediment this area, which is also the area of greatest public use of the lake (marina bay).
 - The objective is to maintain a deep pit in the river as a sediment trap to capture silt from the river before it reaches the lake, slowing the filling of the lake. We have used this strategy in the past, but without sufficient funding to regularly clean out the pit. If not done annually, silt from the river will carry out into the main channel.
 - Enter a ten-year contract with an outside vendor (open bid process). This is a \$300,000 per year commitment: 250,000 to excavate 25,000 cubic yards per year from the river channel (the pits) and surrounding areas, and \$50,000 to be used for emergency clean out of the pits (due to a heavy storm). If not used, the \$50K would role over to the emergency dredging fund or be used to further dredge areas (marina bay and the west end of the lake).
 - The vendor would maintain and operate a hydraulic dredge and pump all spoils into dewatering ponds on either side of the river channel. Under the contract, the vendor will be responsible for removing all sand and aggregates from the site.
- The Balance of the Lake: Trout Stream and Buffalo Creek (RBR), Cane Creek (Tryon Bay), Gray Logs Cove and 39 other tributaries.
 - We believe that these other areas of the lake affected by sedimentation could be maintained at historic depths for approximately \$66,000 per year. This is an estimate calculated using recent dredging expenditures in these areas.
 - Each area has unique characteristics, requiring different dredging strategies and timeframes and costs. Annually, the Lake Advisory Board will conduct a needs assessment and prepare a proposed dredging plan and budget for these areas. Dredging may be hydraulic or excavation, depending on accessibility, depth, options for dewatering and whether it's a lake drawdown year.
 - The Lake Ops department from now on will be making depth reading in all areas of the lake, on a regular schedule. This data will then be used to assess these different areas, and determine where dredging is needed the most.

• Emergency Savings:

• Consistent with Town Council's expressed intent in the year 2000, an annual contribution of \$100,000 should be put into the silt reserve fund to cover the cost of a large post-flood cleanup (known in the past as the "Big Dig"). In 1997, the town dredged the main channel after the flood of '96 at cost of around \$1.4 million (paid

for by FEMA). After that event, FEMA informed the Town that future help was not guaranteed and that a self-insurance fund is recommended. We believe that same project today would cost around \$4 million.

• Today this fund has a balance is \$318,000.
