## **General Meeting Actions:**

- Chairperson Mark Helms called the meeting to order at 3:45 p.m.

## **Individual Meeting Reports and Actions:**

**Lake Operations Department** – Dean Givens reviewed the department's report that was sent to board member by email prior to the meeting and presented a recommendation for approval of the 2015 lake commercial licenses.

After review, Joe Pritchett made a motion to recommend that the 2015 lake commercial licenses be approved as presented by the Lake Operations department. Gary Hasenfus seconded the motion and the vote of approval was unanimous.

## Fishery & Ecosystem – Gary Hasenfus was not present but Mark Helms reported:

The board decided that having the trees delivered at a cost of \$1 per tree would be the best option and discussed a need to determine where the trees should be placed since the lake will be down when the tree are delivered.

## **Regulations & Law Enforcement – Derek Papesh reported:**

• Mr. Papesh reported that the SOP for boat measuring should be ready by the next boating season and stated that he will work with the Lake Operations department to determine what portions of the Lake Use Regulations should potentially be amended and bring those suggestions to the board for consideration. Mr. Papesh suggested that the board may want to continue to look at weight restrictions for boats since length isn't always the greatest determinate of wake.

## **Other Business**

## <u>Consider Recommending an Ordinance Amending Section 94.02 Definitions and 94.05 Design and</u> <u>Construction Standards of the Lake Structure Regulations of the Town of Lake Lure</u>

Clint Calhoun reviewed a proposed ordinance emailed to board members prior to the meeting that was drafted to clarify the Lake Structure Regulations based on the board's discussion during previous meetings. Derek Papesh made a motion to recommend the draft ordinance. Joe Pritchett seconded the motion and the vote of approval was unanimous

Gary Hasenfus stated that he has noticed the Lake Lure Tours boats are not going idol speed in main channel. Board members discussed Lake Lure Tours concession agreement with the town relating to the topic.

The board discussed burning debris in the lake bed while the lake is down. Mr. Givens stated that burning is allowed as long as it is vegetation only and as long as a burn permit is obtained from the fire department.

The board's clerk agreed to contact the Town's Public Information Officer and ask he to work with the Lake Operations Department and the Fire Department to potential send out and email relating to the topic.
