Call to Order and Agenda Review:

Chairman Mark Helms called the meeting to order at 3:30 p.m. and the Board reviewed the Agenda.

Approval of the minutes:

Bill Ashman made a motion to approve the minutes of the November 13, 2017 regular meeting as presented. Gary Johnson seconded and the motion carried unanimously.

Individual Meeting Reports and Actions:

Lake Operations Department – The Board discussed the Lake Operations Department's report that was sent out by Lake Operations Director Dean Givens prior to the meeting. Mr. Givens also reviewed a letter submitted via email from Robert and Elizabeth Iwaoka on November 14, 2017, requesting placement of a buoy seventy feet off the shoreline since their property is on a point of land where many boats pass closely. The email for the Iwaokas also requested that the Board consider changing the no-wake hours in the summer months from 9:00 p.m. to 8:00 p.m. stating that Lake Lure is in a deep gorge so darkness comes very quickly as the sun begins to

lower making it very difficult to see swimmers or fallen water skiers at that time of day. Lake Operations Director Dean Givens stated that does not support allowing a buoy to be placed seventy feet out in the Lake at the location described and he believes the current regulations adequately address the issues described by the Iwaokas. Dan Breneman made a motion to support the Lake Operations Director's recommendation to deny to request for placement of a buoy seventy feet out in the Lake and not amend the current regulations at this time. Gary Johnson seconded and the motion carried unanimously.

Special Topics –

Consider Approval of the 2018 Meeting Schedule- Gary Johnson made a motion to approve the 2018 Meeting Schedule as presented. Dan Breneman seconded and the motion carried unanimously.

Recommended approval of the 2018 Commercial Boat License Applicants - Lake Operations Director Dean Givens presented the 2018 Lake Lure Commercial License Applications Schedule, a lake impact calculator and the 2018 Lake Commercial Licenses Summary of Recommendations. Gary Johnson made a motion to approve the 2018 commercial license applicants as presented. Bill Ashman seconded and the motion carried unanimously.

Discussion Concerning Safety on the Lake - The Board discussed enforcement of current regulations on the Lake, including potentially issuing more citations. The main concerns expressed by the Board are non-permitted boats on the Lake (the Board believes not having a permit on their boats could potentially mean that the boater is unaware of other boating regulations), motorized boat breaking wake in no wake zones, and non-motorized boats operating outside of no wake zones. Chairman Helms agreed to go to the Marine Commission to

discuss the Lake Advisory Boards concerns and ask for additional direction relating to the concerns.

Board Member Areas of Responsibility Reports:

Fishery & Ecosystem – Gary Hasenfus stated that Christmas tree habitats will be placed in the Lake again. The habitats can be placed even with the Lake being down three to five feet this year. Mr. Hasenfus also reported that fishing in the Lake was extremely good in October and November.

Dredging & Watershed Stabilization – Mr. Givens provided an update on dredging in the Lake.
