- Gary Hasenfus made a motion, seconded by David Efird to adjourn the meeting at 8:35 p.m. The vote of approval was unanimous.

#### **Special Topics**

- Lake Use Regulation Changes were presented by Dean Givens:
  - Adding to Section1.57 (Commercial Operations)

(L) Because there are limits in the numbers of commercial boat permits issued, once a boat permit has been issued for a particular commercial classification, that boat shall retain that classification until the permit expires. A boat cannot change classification in the same calendar year that it was permitted. Commercial vessels may only be operated for the purpose approved in the commercial license.

• Amend Section 1.59 for lake commercial licenses: Businesses must operate on the lake for a full season (summer, spring/fall OR winter) to be eligible to receive a lake

commercial license. Commercial activities planned for a day, week or other period less than one full season will not be considered.

- Adding Section 1.99(H) ENFORCEMENT; PENALTIES. It shall be the responsibility of the owner of any permitted vessel, to see that any and all civil fines are paid, in the event an operator using said vessel receives a citation. Failure to pay a lake regulations civil fine within 30 days may result in suspension from further use of the lake, including the forfeiture of boat permits, at the discretion of the Marine Commission.

- MOTION: Gary Hasenfus made the motion, seconded by David Efird to recommend to the MC to adopt the Lake Use Regulations changes and additions as presented by Dean Givens. The vote was unanimous.
- The proposed seawall reconstruction and renovations of the Washburn Marina were presented by Dean Givens.
  - MOTION: Robin Proctor made the motion, seconded by David Efird, recommended to the Town Council to approve the Washburn Marina renovations s presented by Dean Givens as long as the plan is not expanded further than presented (no increase in the number slips or size of the docks) and the interest rate and financing can be arranged that the maximum number of years to pay off any load would be 10 years. The vote was unanimous.
- The schedule for lowering the lake was discussed.
  - MOTION: Robin Proctor made a motion, seconded by Mark Helms to recommended to the TC that the lake not be lowered this year (2010/11) for the following reasons, 1) there is no pressing need to lower the lake this year as it was lowered last year; 2) a Bathymetric study needs to be conducted to determine the siltation process of the lake and therefore the dredging needs for the lake; 3) The Marina alterations, potential Streamside System and Dredging will most likely cause the lake to be lowered next year 3) The Bathymetric study and other inputs need to be used to develop a plan for lowering the lake (timing (annual semi- annual etc. and duration) rather than making spur of the moment determinations year by year. The Motions was unanimous.
- No Wake Time changes were discussed.
  - MOTION: Gary Hasenfus made a motion, seconded by David Efird, to be consistent with Coast Guard regulations, to require no wake speed (idle speed) from ½ an hour after sunset to 7:00 am. The vote was unanimous.

### **Open Action Items**

- Research the overall water sampling program to determine the correct number and location for sample collection and appropriate parameters for analysis.
- Review Lake Structure Regulation changes to be presented by Wiley Bourne and/or Clint Calhoun not discussed during this meeting.
- Areas of Responsibility SOPs still need to be developed.
