RESOLUTION NO. 07-02-13

A RESOLUTION TO AMEND RESOLUTION NO. 00-01-11, PARKS AND RECREATION BOARD; ADDING "ARTS" TO LIST OF DUTIES OF THE BOARD.

WHEREAS, the aforesaid Resolution No. 00-01-11 was duly adopted by the Town Council of Lake Lure, North Carolina on January 11, 2000 in order to establish a Parks and Recreation Board and set forth its duties and responsibilities; and

WHEREAS, at the recommendation of the Parks and Recreation Board, the Town Council finds it desirable to add arts and cultural facilities and activities to the list of duties and responsibilities of the board; and

WHEREAS, it is the intent of the town council that parks, arts, cultural, and recreation facilities be included in the Comprehensive Plan of the Town of Lake Lure; and

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF LAKE LURE, NORTH CAROLINA:

SECTION 1. That paragraph three of the preamble to Resolution No. 00-01-11 is hereby amended as follows:

"WHEREAS, it is in the best interests of both the permanent residents of the town as well as the local tourist industry, which comprises a major portion of the town's economy, for there to be active park, beautification, and recreation programs in an active beautification program of public property and active parks, arts, cultural, and recreation facilities and activities for the Town of Lake Lure; and"

- **SECTION 2.** That Subsection (1) of Section 3 "Duties" of Resolution No. 00-01-11 is hereby amended to add a new subsection (e) as follows:
- (e) Coordinate with the community development director and zoning and planning board to incorporate current and planned parks into the comprehensive plan.
- **SECTION 3.** That Subsection (3)(b) of Section 3 "Duties" of Resolution No. 00-01-11 is hereby amended as follows:
- (b) Formulate and recommend to council programs for active recreation, including sports, playgrounds, physical fitness facilities, scenic and hiking trails, bicycle paths and the like coordinate with the Zoning and Planning Board to incorporate recreation facilities into the Land Use Plan.
- **SECTION 4.** That Subsection (3) of Section 3 "Duties" of Resolution No. 00-01-11 is hereby amended to add a new subsection (e) as follows:
- (e) Coordinate with the community development director and zoning and planning board to incorporate recreation facilities into the comprehensive plan.

SECTION 5. That Section 3 "Duties" of Resolution No. 00-01-11 is hereby amended to add a new subsection (4) as follows:

(4) Arts:

- (a) Formulate and recommend to council plans for an active arts and cultural program and encourage a public/private partnership to develop a vibrant visual and performing arts program for the Town of Lake Lure.
- (b) Identify those properties having potential for public arts or other cultural facilities and recommend to council plans to develop those properties.
- (c) Coordinate with the community development director and zoning and planning board to incorporate arts and cultural facilities into the comprehensive plan.
- (d) Monitor the condition of any public arts facilities and recommend to the town manager programs for maintenance.

SECTION 6. Effective date.

This resolution shall be effective upon its adoption.
