Upon motion made and duly seconded, Nettie Lee Weber was elected Clerk and Treasurer, to hold her office at the pleasure of the Board, and to receive such compensation as may be allowed by the Board.

The above motion was carried by a unanimous vote of all members present.

The Mayor presented a certified copy of the charter of the Town of Lake Lure; and upon motion made and duly seconded, it was unanimously voted that the said charter be received and spread upon the minutes and filed with the Clerk.

Upon motion made and duly seconded, the Clerk was empowered to purchase a suitable book in which the records of the minutes of the proceedings of this Board shall be kept.

Upon motion made and duly seconded, the following resolution was unanimously adopted:

THE IT RESOLVED, that the Corporate Seal for the Town of Lake Lure shall consist of a circular device, the impress of which shall contain the following:

or, the seal may be a device of similar import substantially of the form above set forth.

BE IT FURTHER RESOLVED, that the Clerk be, and she is hereby instructed to produre the said Seal."

Upon motion made and duly seconded, the following resolution was unanimously adopted:

"BE IT RESOLVED, that the regular meetings of this Board shall be held at take Lure Inn, at 5 o'clock P. M., on the first and third Tuesdays of each calendar month; but special meetings of said Board may be had at any time upon written notice given by the Mayor."

B. H. Long tendered his resignation as Commissioner, for the reason that he was appointed by the Legislature without his knowledge, and he finds it impracticable for him to serve.

Upon motion made and duly seconded, the resignation of Mr. Long was accepted with regrets of his Board.

Upon motion made and duly seconded, S. V. Hooker was elected as Commissioner of the Town of Lake Ture to succeed Commissioner Long. Thereupon, Mr. Hooker took the oath of office as Commissioner, which said oath is as follows:
