MINUTES OF A REGULAR MEETING OF THE BOARD OF COMMISSIONERS OF THE TOWN OF LAKE LURE, N.C. HELD IN THE TOWN OFFICE AT LAKE LURE, N.C. TUESDAY MARCH 10,1953 AT 7.30 P.M.

At a regular meeting of the Board of Commissioners of The Town of Lake Lure, N.C. held in the Town Office at 7.30 P.M. Tuesday March 10,1953, the following were present;

L.M, Pearson, Jr., Mayor W.C.Allison, Commissioner Chas.R. Yopp, Clerk.

Mr. Fred Hamrick, Town Attorney, met with the Board and discussed pending suits against the Town relative to defaulted Bonds. The matter of the Town selling certain real estate holdings was brought up and discussed, abso. An effort is to be made by Mr. Hamrick to secure Quit-Claim Deeds so that real estate may be sold without any question as to the Town's Right to convey for purposes other than for parks.

The matter of the contract with the Carolina Mountain Power Corp. for the year beginning April 1st was brought up. The Power Corp. has agreed to the same provisions as last year, 50 % of the total gross receipts from lake permits to both the Town and the Power Co. There is a possibility that a sale of the property may be made and it was agreed that with 30 days notice after Sept. 1,1953, the Power Corp. may cancel the contract by refunding the pro rata cost or the unused are unexpired portions of all outstanding lake permits.

Mr. Hamrick is to prepare certain ordinances for the Town to cover especially the operation of boats on the Lake. Thesex ordinances will be attached to this sheet.

A lease of the Town docks was to be prepared by Mr. Hamrick for W.E.Franks and J.A.Jones. The Town is to receive 10 % of the Gross Revenue under the terms of each contract.

SELLERS WILL BE ALLOWED A COMMISSION OF 10 CENTS EACH ON EACH FISHING PERMIT SOLD, THE COMMISSION ON THE DAILY BOAT PERMIT WILL BE 20 CENTS FOR EACH PERMIT AND ON THE SEASON BOAT PERMITS 10 CENTS ONLY.

IT WAS, ALSO, AGREED THAT J.A.JONES BE PERMITTED TO SELL THE SEASON AND DAILY BOAT PERMITS IN CONSIDERATION OF HIS AGREEING TO SEE THAT BOATS ARE PROPERLY NUMBERED.

NO NUMBER REQUIRED FOR THE DAILY BOAT PERMIT WHICH MAY BE SOLD BY OTHERS, IF THE BOARD SO DECIDES.

Upon motion duly made and seconded, the following ordinance to regulate boating on the waters of Lake Lure was unanimously adopted:

RESOLVED:

- 1. This ordinance shall apply to all boats now or hereafter placed or operated upon the waters of Lake Lure, North Carolina.
- 2. No person, firm or corporation shall place or operate a boat or boats upon said lake without first obtaining a license from the Town Board of the Town of Lake Lure authorizing the placement or operation of said boat or boats.
- 3. All persons who desire to place or operate a boat or boats upon the waters of Lake Lure shall apply to the Town Board of the Town of Lake Lure for a license to operate such boat or boats.

  The Town Board of the Town of Lake Lure shall consider each application.
  - 4. All boat licenses shall be issued in the Town Office of the Town of Lake Lure after the person, firm or corporation applying for said license has been approved by the Town Board of the Town of Lake Lure. PROVIDED, however, that the Town Clerk of the Town of Lake Lure or any policeman employed by the Town of Lake Lure shall have the authority to issue temporary licenses which shall be good until the application for such temporary license has been approved
  - 5. The Town Board shall fix the fees to be charged for all boat licenses issued by said Town and shall have the right to fix different fees for the following classes of persons:
    - (a) Residents
    - (b) Fersons who own property in the Town of Lake Lure
    - (c) Non-resident non-property owners
    - (d) Persons who operate boats for rent

No license shall be issued and no boat shall be placed or operated upon said lake until the license fee fixed by the Town Board of the Town of Lake Lure has been paid in full.

- 6. The Town Board shall, in its discretion, issue season licenses, daily licenses, weekly licenses, or 5-day licenses, the 5-day licenses to be issued only to persons who rent rooms or cottages for one week or more and who wish to bring their own boats with them.
- 7. Each boat license issued by the Town Board of the Town of Lake Lure pursuant to this ordinance shall contain a boat number, which boat number shall be displayed at all times by the owner of said boat in a prominent place on both sides of the front of the boat covered by said boat license.
- 8. All persons, firms or corporations operating a boat or boats on Lake Lure shall operate the same subject to the following provisions of this ordinance:
  - a) Each boat operated on said lake shall at all times have in said boat a suitable and safe life preserver for each person in the boat.
  - b) No person shall engage in boat racing on Lake Lure.
  - c) There shall be no water skiing in the coves of Lake Lure.
  - d) Any person operating a boat upon Lake Lure shall operate same in a careful and prudent manner and so as not to endanger the life or property of any person on or near the waters of said lake.
  - e) It shall be unlawful for any person to operate a boat upon Lake Lure in a careless or reckless manner or so as to endanger the life or property of any person upon or near said lake. It shall also be unlawful for any person to permit any boat owned by him to be operated in a careless and reckless manner or so as to endanger the life or property of any other person upon or near said lake.
  - f) Any person who shall violate any of the terms of this ordinance shall forfeit his license to crowsta
