MINUTES OF A REGULAR MEETING OF THE BOARD OF COMMISSIONERS OF THE TOWN OF LAKE LURE, N.C. HELD IN THE TOWN OFF TICE IN LAKE LURE, N.C. TUESDAY OCTOBER 13,1953 AT 7.30 O'CLOCK P.M.

At a regular meeting of the Board of Commissioners of the Town of Lake Lure, N.C. held in the Town Office at 7.30 o'cluck P.M. Tuesday Oct. 13, 1953, the following were present:

L.M. Pearson, Jr., Mayor S.A. Eudy, Commissioner, Wm.C.Allison, Commissioner, Fred D. Hamrick, Town Attorney, Chas.R. Yopp, Clerk to the Board.

Also, present were V.T. Salter and J.C. Binder as visiting representatives from the Civic Club.

The meeting was called to order by the mayor, L.M.Pearson, Jr., who welcomed the visitors.

A letter signed by Mr. C.Roy Smith asking that the Town open a certain road running off the Holmes Road so that there may be two entrances from the State Highway into the said Holmes Road was read to the Board. After some discussion, the clerk was instructed to address Mr. Smith and suggest that he ascertain just how much money he might raise to apply on the cost and to advise that the Town would help some. It was brought out that the Town will take over and keep road in shape but that the Town has never actually constructed any road or street, that no new homes would ever be built along the proposed road and that the cost of constructing such road might run better than \$400.00.

The Mayor was authorized by the Board to have three (3) copies of maps, showing the several lots owned by the Town under Commissioners Deeds, prepared so that prospective purchasers might be shown the properties. These lots are to be sold at Court House Door, Saturday Nov. 7th, 1953. It was decided to purchase a new truck for the Street Dept. and let the present truck be used for Garbage collection. Mr. S.A. Eudy, Commissioner, was authorized to secure prices of such truck from three (3) different concerns and submit to the Board for their action.

At a Special Meeting Sept. 17th, the Mayor was authorized to purchase a pump for the water dept. The Board decided instead to authorize that a new well be dug instead at this time and that the pump would be purchased at a later date. The well to cost approximately \$750.00.

On motion of W.C.Allison, Commissioner, the motion being duly seconded and and unanimously passed, a charge of \$100.00 per annum was fixed for the use of the Town's Trash Dump by the Community of Ckimney Rock. The fee may be paid in monthly payments of \$8.33.

A general discussion among the Board members and the Civic Club representatives regarding the improvement of the beach, construction of a bath house dredging or pumping out of the lake along the bathing beach and other matters in connection with the development of our Town, was had. No specific action was taken but Mr. V.T. Salter is to confer with others in an effort to arouse interest and sentiment of our people to the point that capital will be raised and improvements and developments be realized.

No further business appearing, the meeting adjourned.
