Mr. C.Roy Smith appeared before the Board and asked for consideration of the proposition to open a certain road running off the Holmes Road. This matter was presented at the Oct. 13,1953 meeting and no action taken. The matter was discussed and no action taken.

It was moved, seconded and unanimously approved that the Town have lights installed along the Beach side of the Highway from approximately where the Jaegers road enters the Highway to approximately im front of the G.F.Davis property. Eighteen lights in all to be installed. The Town owns the poles which they will set and the lights to cost 43.18 each installed. Purchase of the lights unanimously approved after motion and second.

The sale of the 25 lots which the Town rejected and offer of \$800.00 at a regular meeting of the Board of Commissioners Nov. 10,1953, was approved at an offer of \$1,000.00 by J.R.Washburn. The deed to be made to J.R.Washburn and Forrest M.Edwards jointly.

The board was advised that the Carolina Mountain Power Corporation had been addressed relative to a lease of the Lake for the fiscal year to begin at April 1,1954 and end March 31,1955 under the same terms as lease for last year.

On motion duly made and seconded and unanimously adopted, Commissioner Eudy was named purchasing agent for the Town of Lake Lure, N.C.

It was decided to remt that certain farm owned by the Town of Lake Lure, N.C. to C.H.Burgess for the year 1954 at an agreed rental of \$ 50.00 to be paid by the said C.H.Burgess to the Town of Lake Lure, N.C.

No further business appearing, the meeting adjourned.
