MINUTES OF A REGULAR MEETING OF THE BOARD OF COMMISSIONERS OF THE TOWN OF LAKE LURE, N.C. HELD IN THE TOWN OFFICE IN LAKE LURE, N.C. TUESDAY MAY 11,1954 at 7.30 O'CLOCK P.M.

At a regular meeting of the Board of Commissioners of the Town of Lake Lure, N.C. held in the Town office in Lake Lure, N.C. at 7.30 P.M. Tuesday May 11,1954, the following were present-

The meeting was called to order by the Mayor, L.M. Pearson, Jr.

On motion made and duly seconded, the purchase of a Model L Gravely 5 HP. tractor with a 30" Reel Type Mower and Rotary knife Mower assembly was approved. Prices were submitted by Gravely Tractor Co., Dunbar Virginia and E.P.Nisbet Co., of Charlotte, N.C. at 565.46. King Hdw.Co. of Hendersonville, N.C. submitted a price of \$540.00. The bid of King Hdw. Co. was accepted. Mr. Eudy, Commissioner, is to handle for the Board.

Mr. Robert H.Cooke, C.P.A. who has audited the Town's records for the past 2 years, submitted a bid of \$192.00 to audit the records for the fiscal ending June 30,1954. On motion duly seconded and unanimously carried, the offer was accepted and the clerk instructed to so advise Mr. Cooke.

The mayor, Mr. L.M.Pearson, reported that he was in touch with a party who was interested in putting ponies for riding children on the beach. He, this party,would pay \$12.50 per pony for each pony,would pay in advance, and would see that space is kept clean at all times. On motion by Mr. Allison,duly seconded and carried, the proposition was approved and Mr. Pearson will complete the contract with the interested party.

On motion of Mr. L.M.Pearson, Jr., Mayor, which motion was seconded and unanimously carried, the following ordinance was adopted;

RESOLVED : That from and after this date, it shall be unlawful for any person, firm, or corporation within the corporate limites of the Town of Lake Lure, N.C. to operate outside of a building, or in the open, a loud speaker or other dewice mechanical, electrical, or otherwise for amplifying or broadcasting sound after the hour of 11 o'clock P.M. and before the hour of 9 A.M. Any person, firm, or corporation who shall viblate this ordinance shall be fined not more than \$50.00 or imprisoned not more than thirty (30) days, or both in the discretion of the Court. Each day on which any such device shall be operated shall constitute a separate offense.

Mr. Larry Phillips appeared before the Board and asked that the ordinance adopted by the Board June 9,1953 as recorded on Page 66-2 of this Minutes Book, which ordinance makes it unlawful to operate a public dance hall after the hour of 12 o'clock P.M. and before the hours of 10 o'clock A.M., be AMENDED to read that it shall be unlawful to operate a public dance hall after the hour of One (1) o'clock A.M. and before the hour of 10 o'clock A.M. (Over) After discussion a motion was made by W.C.Allison duly seconded by L.M, Pearson, Jr. and unanimously carried as follows-

RESOLVED : That an ordinance duly adopted by the Board of Commissioners of the Town of Lake Lure, N.C. June 9,1953 as recorded in this Minutes Book at Page 66-2 which ordinance prohibits the operation of a public Dance Hall after 12 P.M. and before the hour of 10 A.M., BE AMENDED TO read that it shall be unlawful to operate a public dance hall after one (1) A.M. and before 10 o'clock A.M.

No further business appearing, the meeting adjourned
