MINUTES OF A REGULAR MEETING OF THE BOARD OF COMMISSIONERS OF THE TOWN OF LAKE LURE, N.C. HELD IN THE TOWN OFFICE AT 7.30 P.M.TUESDAY SEPT. 13,1955AT LAKE LURE, N.C.

At a regular meeting of the Board of Commissioners of the Town of Lake Lure, N.C. held in the Town Office at 7.30 P.M. Tuesday Sept. 1955, the following were present-

L.M.Pearson, Jr., Mayor W.E.Franks, Commissioner Dornan Gresley, Commissioner

Fred D. Hamrick, Jr., Town Attorney Chas. R. Yopp, Clerk

Among visitors present and recognized by the Mayor, were David Lahn, Bud Washburn, and Francis Proctor.

The Mayor brought up the matter of providing benches and score boards for the shuffle board court. On motion duly carried, the purchase of benches and score boards was approved. The Board, also, authorized the purchase of four (4) Recapped tires and two(2) new tires for the truck being used by the Garbage Dept. It was decided to have built a body for this Garbage truck in order that a larger load might be carried and trips to the garbage dump saved. The cost of such body was estimated to be between 150.00 and 200.00.

On motion of Commissioner Franks, duly seconded, the Mayor, L.M. Pearson, Jr. was named Buyer for the Town or Purchasing Agent. And he, the Mayor, is to secure prices on the tires, body, and tires mentioned above with authority to purchase at the best figures.

The Board was advised that Wm.E.Franks, Jr. who has been serving as a police officer and Lake Warden, had resigned to accept another position. He, Mr. Franks, agreed however to check the Lake Saturdays and Sundays and to serve as an officerif called at other times when here at night. To this the Board agreed, and a salary of \$50.00 per month was agreed upon. Mr. Hamrick is to draw a lease for certain property which is part of the Golf Course tract and which one Ross Wagner has fenced and uses for a pasture. The lease to run from year to year at the Town's pleasure and the rental \$1.00 per year.

Mr. David Lahn discussed the possibility of locating certain manufacturing plants in the Town limits and ,also, the possibility of a group or body of citizens taking over and operating the Golf Course which was offered at \$1.00 per year rental. Mr. Hamrick discussed the possible Lake purchase by the Town reading letters pertaining to same. The new offer from the C.M.P. Co. is to be received about Nov. 1,1955. It is hoped that something then knay be done about closing a deal. The matter of tax sales or foreclosures was discussed with no action. The Board unanimously decided to relieve Robert Wilson and Miles Edwards of their duties with the Town and to operate the garbage collection with one man, Edward Montgomery. The Clerk was instructed to advise Mr. Cal Wilson of the order.

No further business appearing, the meeting adjourned.
