

MINUTES OF A REGULAR MEETING OF THE BOARD OF COMMISSIONERS OF THE TOWN
OF LAKE LURE, N.C. HELD AT 7.30 P.M. IN THE TOWN OFFICE IN LAKE LURE, N.C.
TUESDAY OCTOBER 11, 1955

At a regular meeting of the Board of Commissioners of the Town of Lake Lure, N.C. held in the Town Office in Lake Lure, N.C. at 7.30 P.M. Tuesday October 11th, 1955, the following were present

The Mayor welcomed Mr. David Lahn and Mr. W.E. Franks, Jr. who were present.

After the meeting was called to order by the Mayor, Mr. J.S. Goode of the Picturesque Publishing Co., Asheville, N.C. presented to the Board an advertising proposition for a magazine to be delivered about Jan. 1956. The Board agreed to purchase 3 pages at a cost of \$150.00 and we are to be given another 3 pages of photos and cuts at no additional cost. Also, 25 copies are to come to the Town FREE and further copies may be had at 25 cents per copy. The Contract is filed under Paid Bills for Sept. but actual payment has not been made and will not be until magazines are received.

The Clerk was instructed to address Ross Wagner concerning the lease he must sign for the land he is presently using at end of Golf Course and to advise that unless lease is executed immediately, he will be compelled to vacate.

It was decided by the Board to continue to pay one Curtis Wagner \$4.50 to relieve Ray Vess at Golf Course on Sundays. At any time that LESS THAN \$4.50 is collected, the Board reserves the right to cancel this order.

The Clerk was instructed to prepare statements of the delinquent taxes due on the property of D.W. Stanfield & J.W. Temple, deceased, and also on the old garage in name of Clarence Davis and submit to the Town Attorney, Mr. Fred D. Hamrick, Jr., for foreclosure proceedings.

Mr. Hamrick discussed the possibility of the Bond Suit being continued so that we may secure some FINANCIAL AGENT OR BOND CONCERN to prepare a schedule pertaining to the possible purchase of the Lake by the Town. Mr. Thacker, who was to prepare, is unable because of sickness to do this. Mr. Hamrick will advise as soon as he is able to arrange. Mr. Lahn discussed the possibility of organizing a Chamber of Commerce in and for the Town of Lake Lure. The proposition was heartily approved by the Board. It was made clear that it was to be a purely Civic matter, no politics were to enter the formation or operation and that it will be distinctly separate from any connection with the Town whatsoever.

No further business appearing, the meeting adjourned.
