MINUTES OF A SPECIAL CALLED MEETING OF THE BOARD OF COMMISSIONERS HELD INXTHE TOWN OFFICE AT 8.30 A.M. MONDAY APRIL 22.1957

Mr. WM.E.Franks and Mr. Dornan Gresley, Commissioners called for the meeting. Waiver of Notice of said meeting was agreed to by all- Wm.E.Franks and Dornan Gresley, Commissioners and L.M.Pearson Jr., Mayor.

The Mayor, L.M. Pearson, Jr., opened the meeting and recognized Mr. Franks. Mr. Franks moved that the services of the chief of polie, Mr. A.G. Huskey, be dispensed with immediately. There was no second. Mr. Gresley then moved that Mr. Huskey be granted a 2 weeks vacation with pay and that he be paid for a weeks vacation to which he was entitled. Mr. Franks amended the motion to read "That it be demanded of Mr. Huskey that he take this 2 weeks leave of absence" The vote was then taken and carried by 2 to 1, Mr. Franks and Mr. Gresley voting for and Mr. Pearson against. Mr. Pearson asked Mr. Franks the reason for such a motion and what charge, if any, he wanted to bring against Mr. Huskey. Mr. Franks replied that he "Didn't like the way Mr Huskey talked to him over the phone"

Mr. Pearson asked that he be recorded as voting against the motion. He, also, espressed the opinion that Mr. Franks was making a political sacrifice of Mr. Huskey and that it was unfair politics.

Motion was made to adjourn and carried.

After the transaction of the above matter, Mr. Pearson brought up the matter of blacktopping the first mile of the Buffalo Creek Road beginning at Highway # 74. It was agreed that \$2,000.00 of the money received from the Powell Bill be allocated for this work and the Clerk was instructed to so advise Mr. Flemming Snipes, State Highway Commissioner. The State is to grade and rebuild the road where necessary and keep it up. The only expense to the Town will be the cost of black topping, the estimated cost being \$1,800.00 per mile.
