MINUTES OF A REGULAR MEETING OF THE BOARD OF COMMISSIONERS OF THE TOWN OF LAKE LURE, N.C. HELD IN THE TOWN OFFICE IN LAKE LURE AT 7.30 P.M. TUESDAY JUNE 11.1957

At a regular meeting of the Board of Commissimeners of the Town of Lake Lure, N.C. Tuesday P.M. June 11,1957, the following were present-

The minutes of the last regular meeting of May 14th,1957 were read and approved.

Mr. Smith presented to the Board the fact that the Winston -Salem,N.C. Chember of Commerce was sponsoring an advertising campaign "Vacation in North Carolina" and that we, the Town of Lake Lure, along with other municipalities were invited to participate. It will run for 3 days in Winston-Salem. The Town will be given window space and will be permitted to send a representative to talk for the Town, distribute folders and literature and do all possible to advertise Lake Lure. The Civic Club will take care of expenses save that the Town has by motion duly made , seconded, and adopted, appropriated \$50.00 to \$75.00 to cover expenses of its representative. Mr. C.Roy Smith has agreed to represent the Town.

The Clerk is to contact Dr.Moss, County Health Supt., and ask that he investigate complaints as to outdoor privies especially one used on the property of one Z.L.Cash in the Town limits. On motion duly made, seconded and unanimously passed, named as Town Clerk and Treasurer Mrs. Blanche B.Liles. The term fixed is at the pleasure of the Board and the salary is to be \$175.00 monthly.She is to begin June 15th, 1957 as assistant and at July 1st, 1957 to take over as Clerk & Treasurer.

The Board agreed to accept \$5.00 monthly as rentalm for the use of the Garbage dump by requiring that Mr. Zeb Dalton be held responsible for the collection of the \$5.00 monthly. It was ,also, agreed that a Mr. Burgess may use that certain land at the upper end of the golf course property for farming without money cost but that for this privilege he agree to plow around the garbage when necessary in order to prevent a fire hazard.

A tentative budget for the fiscal year 1957-1958 was presented and discussed by the Board and Clerk. No positive action was taken but the appropriations as shown were agreed to. Formal adoption will be made at the regular August meeting.

The Clerk was instructed to accept in full satisfaction the sum of \$20.14 for the \$54.93 water bill to Lake Lure Inn for the month of Sept. 1955. The bill has been hanging unpaid, The Inn claiming it wasn't used as they had few guests etc. So in order to close, the Board accepted this amount (20.14) which is a check due by the Town to the Inn written April 10th and which we had held back.

Discussion of the possible erection of a Town Hall, pumping out of the Lake, and developing the Beach was heard but no action taken. The Mayor advised that we might expect donations and memberships for the Golf Club and gave the Clerk \$25.00 for a membership for Leon Hyder, Hendersonville, with instructions to mail a card to Mr. Hyder. No further business appearing, the meeting adjourned.
