Two members of the Board were present.

The Mayor called the meeting to order and welcomed the visitors, Mr. J.V.Bell, Mr. W.R.Hackett, Jr and Mrs. Strangward, all Lake Lure Residents.

Mrs. Strangward called to the attention of the Board the need of widening of the Island Road and the cutting of a large oak tree on Dr. Ables lot, the tree leans over the road and presents a hazard according to Mrs. Strangward.

Mr.Bell and Mr. Hakkett were visitors from the Lake Lure Civic Association; Mr. Hackett wasasked by the Town Board to contact Dr.Able for permission to cut the Oak Tree.

The visitors were excused and the business of the meeting was in order.

Mr. W.C.Bolick, Town Accountant met with the Board to discuss a possible tax rate cut. Mr. Bolick advised the Board not to cut the tax rate this year.

It was unanimously agreed by the Board to buy a new tractor and mower from Cornwell Tractor Co., of Forest City, N.C. the old tractor used at the Golf Course was traded in on the new tractor and mower. The New Tractor less the trade-in \$2875.54 , the old tractor bought back, \$300.00, a total of \$3175.54 for the two tracbors.

The Clerk read a letter from Nathan H.Yelton of the State Social Security Board asking the Town Board to pass a resolution for coverage of all elegible groups of Town Employees.

Mayor Wilson made a motion that the Town Board adopt a resolution that all elegible groups of Town Employees be covered by Social Security. The Motion was seconded by Comm. Nelon and was carried. The blanks sent by Mr. Yelton were signed by Mayor Wilson and Comm. Nelon, signed and sealed by the Clerk and was forwarded to the State Social Security Agency at Raleigh, North Carolina. A copy of the blanks and the Resolution are included in the June Minutes.

The 1963-1964 Fiscal Year Budget was discussed, no action was taken, the tenative budget will be read a second time and adopted at the July meeting.

It was unanimously agreed by the Board to write off the 1952 taxes according to the North Carolina Tax Laws.

It was unanimously agreed by the Board to increase the Clerks salary \$25.00 per month, beginning with first Month of the fiscal year.

(d) That a signed copy of these minutes be furnished to the Carolina Mountain Power Company.
