Resolution Enlisting In North Carolina Local Government Employees' Retirement System.

WHEREAS, the 1945 General Assembly amended the North Carolina Local Governmental Employees' Retirement System so as to make the bone-fits of said System available to all Counties, Cities, and Towns, and

WIEREAS, the governing body of this Unit realizes the necessity of providing its employees with the Security and protection provided by a sound reitrement plan, and

WHEREAS, Article 3 of Chapter 128 of the General Statutes of North Carolina provides that any governmental unit desiring to enroll its employees in said System shall make application to the Board Of Trustees of the North Carolina Local Governmental Employees' Retirement System and shall by resolution elect to participate in said System.

Now, Therefore, be/resolved by the Town Board of Lake Lure in regular session, June 14, 1965,

- 1. THAT the Town Of Lake Lure hereby elects to participate its employees in the North Carolina Local Governmental Employees' Retirement System.
- 2. THAT the Town Board hereby agrees to comply with all provisions of the North Carolina Local Covernmental Employees Retirement System as defined in Article 3, Chapter 128 of the Statutes of the General Statutes of North Carolina as amended by the 1945 General Assembly.
- 3. That the <u>Clerk</u> is hereby ordered and directed to make application to the Board of Trustees of the North Carolina Local Governmental Employees' Retirement System for enrollment of this Unit and its employees in said System

A RESOLUTION SUPPLEMENTING AND AMENDING THE RESOLUTION AUTHORIZING THE ISSUANCE OF \$390,000 ELECTRIC POWER FACILITY REVENUE BONDS, ADOPTED ON MARCH 27,1964, AS AMENDED BY A RESOLUTION ADOPTED ON MAY 31, 1965

WHEREAS, the Board of Commissioners on March 27, 1964, adopted a resolution entitled:

A RESOLUTION AUTHORIZING THE ACQUISITION OF THE LAKE KNOWN AS LAKE LURE, TOGETHER WITH A TRUNK SEWERAGE LINE, DAM AND ELEC-TRIC POWER GENERATING PLANT AND ANCILLARY FACILITIES, BY THE TOWN OF LAKE LURE, NORTH CAROLINA: AUTHORIZING THE ISSUANCE, UNDER THE PROVISIONS OF THE REVENUE BOND ACT OF 1938 and CHAPTER 437 OF THE 1963 SESSION LAWS OF NORTH CAROLINA, OF REVENUE BONDS OF THE TOWN PAYABLE SOLELY FROM REVENUES, TO PROVIDE FUNDS FOR PAYING THE COST OF SUCH ACQUISITION; PROVIDING FOR THE COL-LECTION OF RATES, FEES AND CHARGES AND FOR THE CREATION OF CERTAIN SPECIAL FUNDS: PLEDGING TO THE PAYMENT OF THE PRINCIPAL OF AND THE INTEREST ON SUCH REVENUE BONDS CERTAIN NET REVENUES OF SAID PROPERTY HERE-IN AUTHORIZED TO BE ACQUIRED; AND SETTING FORTH THE RIGHTS AND REMEDIES OF THE HOL-DERS OF SUCH BONDS.

WHEREAS, the resolution adopted on March 27, 1964, was amended by a resolution adopted on May 31, 1965 (said March 27, 1964 resolution as amended being hereinafter sometimes called the "Resolution"); now, therefore

BE IT RESOLVED by the Board of Commissioners of the Town of Lake Lure:

Section 1. Articles II and III of the Resolution are hereby supplemented and amended to show that the bonds which mature after May 1, 1974 (rather than May 1, 1973) may be redeemed on any interest payment date not earlier than May 1, 1974, in the manner set forth in the Resolution.
