rides during the summer months.


The Clerk read a letter from Almon Brannon, President

mation.


The 1966-1967 estimated budget was unanimously


At a special meeting of the Board of Commissioners of the Town of Lake Lure, held in the Town Hall August 8, 1966 at 10:15 A.M., the following resolution was unanimously passed.

A waiver of notice of said meeting was read and ordered attached to the minutes of said meeting.

" It shall be unlawful for any person, organization or Corporation to sponsor and/or operate any public dance hall at which event an admission or membership fee is charged or at which a purchase is required for admission as a participant or spectator."

" Anyone violating any provisions of the above shall be guilty of a misdemeanor and fined not more than \$50.00 or imprisoned not more than 30 days."
