The Mayor brought several letters before the Board, which were read and discussed;

The James J. Infantinos requested information on the erecting of a Motel on Highway 74 East on the Timber Cove Property. The Clerk was instructed to forward the required information.

A letter was read from James B. Blanton, Forest City, requesting that a new water line be run to the houses in Snug Harbor, the present water line crosses the Lake, in the Winter when the Lake is low water lines freeze and these houses have no water. Mr. Blanton states that, he would like to use his house during the winter months, but water is not available during the cold weather.

The Mayor suggested that these houses could be put on the water reservoir serving the Snug Harbor Colony. This idea to be looked into.

A building permit was presented to the Board by Mr. Turner of Spartanburg, the permit for a fruit stand on Highway 74 East was turned down, no parking area, no place for a septic tank, lot not large enough for a desirable building.

The Clerk was instructed to write Mr. P. J. Abernethy, the engineer for the Proposed disposal plant to make the preliminary plans for the disposal plant and give us a cost estimate, these plans and estimate to be in Raleigh, N.C. by April 1, 1967.






