MINUTES OF THE MEETING OF THE BOARD OF COMMISSIONERS OF THE TOWN OF LAKE LURE Tuesday, February 11, 1969

The regular meeting of the Board of Commissioners was held at the Town Hall at 7:30 o'clock P. M. on February 11, 1969. The following members of the Board were present:

J. Paul Wilson, Mayor Robert B. Jones, Commissioner Woodrow Price, Commissioner

Hollis M. Owens, Jr., Town Attorney, was also present.

The Mayor, J. Paul Wilson, called the meeting to order, and the Clerk read the minutes of the last meeting. The minutes were approved as written.

The Mayor welcomed Lawrence R. Phillips and Robert E. Chew, citizens of Lake Lure, to the meeting.

Mayor Wilson opened the meeting for a discussion of the schedule of charges and fees for residential and business property presently connected and to be connected in the future to the Lake Lure Sewer System. Mr. Lawrence R. Phillips promised to pay the amount owed by him for sewage fees within the week.

The matter of an Alcoholic Beverage Control Store to be established within the Town of Lake Lure was discussed at length. The attention of the Board was called to the fact that a statewide bill is pending in the North Carolina General Assembly and that if enacted into law, this bill would have the effect of allowing the citizens of the Town of Lake Lure to vote on the question of whether an Alcoholic Beverage Control Store should be placed within the corporate limits of the Town of Lake Lure. After discussion, Commissioner Jones moved, seconded by Commissioner Price that the following Resolution be adopted:

WHEREAS, THE Board of Commissioners of the Town of Lake Lure have been advised that legislation is now pending in the General Assembly of North Carolina which, if enacted into law will permit the citizens of the Town of Lake Lure to vote on the question of whether an Alcoholic Beverage Control Store should be established within the corporate limits of the Town of Lake Lure; and

WHEREAS, the Board of Commissioners wishes the citizens of the Town of Lake Lure to have the opportunity to vote on this question.

NOW, THEREFORE, BE IT RESOLVED:

l. That Senator Clyde Norton and Representatives Robert Jones, Robert Falls and W. K. Mauney, be asked to support the said legislation now pending in the North Carolina General Assembly and to do everything possible to secure its passage.

2. That Mayor J. Paul Wilson be, and he is hereby authorized and directed to contact Senator Clyde Norton, and Representatives Robert Jones, Robert Falls and W. K. Mauney and to ask the said Senator and Representatives to support the aforementioned pending legislation.

The foregoing resolution was unenimously passed.

The tax rate for the fiscal year 1969-1970 was discussed. While no decisions were made, it was the feeling of the Board that the rate should be left at \$1.45 per \$100.00 valuation.

There being no further business, the meeting adjourned at 10:00 o'clock P. M.
