

MINUTES OF REGULAR MEETING OF BOARD
OF COMMISSIONERS OF THE TOWN OF LAKE LURE
TUESDAY, OCTOBER 13, 1970

The regular meeting of the board of commissioners was held in the town hall at 7:30 P.M. on October 13, 1970. The following members of the board were present: Mayor J. Paul Wilson; Commissioners J. Paul Wilson and Woodrow Price. Hollis M. Owens, Jr., town attorney, was also present.

The Mayor, J. Paul Wilson, called the meeting to order and the clerk read the minutes of the last meeting. The minutes were approved as written.

The Clerk advised the board that if the Town of Lake Lure is to continue the open burning of garbage, under new regulations of the North Carolina Department of Water and Air Resources concerning air pollution, the town will have to submit an application for a temporary permit. After discussion, Commissioner Jones moved, seconded by Commissioner Price, that the following resolution be adopted:

WHEREAS, on July 1, 1970, the North Carolina Department of Water and Air Resources adopted rules and regulations governing air pollution, which said rules and regulations relate to the open burning of garbage by municipalities and

WHEREAS, in order to continue the open burning of garbage it will be necessary for the town of Lake Lure to submit an application for a temporary permit and

WHEREAS, the Town of Lake Lure will discontinue all open burning of garbage as of November 1, 1970;

NOW THEREFORE, BE IT RESOLVED, AS FOLLOWS:

(1) That the Town of Lake Lure stop all open burning of garbage on October 31, 1970, and thereafter;

(2) That the Town Clerk and Treasurer, be and she is hereby instructed to notify Cleston Burgess, garbage collector, by certified mail, return receipt requested, that after October 31, 1970, no open burning of garbage will be permitted at the Lake Lure Garbage dump or on any other property owned by the Town of Lake Lure.

(3) That the North Carolina Department of Water and Air Resources be notified of the passage of this resolution.

The following commissioners voting in the affirmative: J. Paul Wilson, Mayor; Robert B. Jones, Commissioner, Woodrow Price, Commissioner.

The following commissioners voting in the negative: none.

Upon motion of Commissioner Price, seconded by Commissioner Jones and unanimously passed, the Board agreed to lower Lake Lure five feet (5) for a period of 30 days, beginning on December 1, 1970, for the purpose of permitting property owners to repair boat houses and docks.

Charges for fishing permits and boating permits for the 1971 season were discussed.

Upon motion of Commissioner Jones, seconded by Commissioner Price, and unanimously passed, the board decided not to make any changes in the charges for fishing permits for the 1971 season.

Decision regarding the charges for boating permits will be made at a later meeting.

There being no further business, the meeting adjourned at 10:30 o'clock, P.M.
