

MINUTES OF A REGULAR MEETING
OF THE BOARD OF COMMISSIONERS OF
THE TOWN OF LAKE LURE, N.C.
MARCH 12, 1974

Mayor Paul Wilson called the meeting to order at 7:30 P.M. and asked Marlene Wilson to read the minutes of the last meeting, February 12, 1974. Upon reading, a motion was made by Don Cothran and seconded by Jim Nance that they be accepted as read. The vote was unanimous.

Jim Morris, representing the Hickory Nut Gorge Fire Dept., asked for a sum of \$500.00 to be donated to the Dept. by the Town of Lake Lure. Don Cothran made a motion that this be accepted in the Town budget for 1974-1975. Jim Nance seconded the motion. The vote was unanimous.

Jim Morris ask if it would be O.K. with the Town Officials to charge ten cents a dance for the street dance this summer. The band will cost \$100.00 and this would be a way to help with expences. Mr. Nesbitt felt there would be no problem in doing this.

Mr. Joe Bell asked, prior to the new budget, to have an open meeting and explain the budget to the public. Mayor Paul Wilson agreed.

Mayor Paul Wilson read the ordinance on the fishing permits for the Town of Lake Lure. Don Cothran made motion to adopt the ordinance. Jim Nance seconded the motion. The vote was unanimous.

Mayor Paul Wilson read the Town Ordinance on fishing boats. No comments were made. Jim Nance made motion to adopt the ordinance. Don Cothran seconded the motion. The vote was unanimous.

Mayor Paul Wilson read the resolution on the sewerage system for the Mountains Development Inc. It was adopted by the Board of Commissioners of the Town of Lake Lure subject to approval by the Dept. of Natural and Economic Resources, Office of Water and Air Resources, Resolution not to take effect until such approval is received from Mr. Hubbard.

Mr. Cothran reported that Mr. Brown had called the Midwest about the Mud Cat. They will be here on the 18th of March if a letter is sent to them agreeing on \$9,000.00 for thirty days, 170 working hours. This was to be signed by the Mayor or one of the Commissioners, written by Mr. Brown. Mr. Nesbitt asked to see the letter before signing.

Jim Nance reported that he had talked to Mr. Max Padgett about the garbage cans for the Town. Mr. Padgett could be of no help.

Don Cothran asked about purchasing signs for the Town of Lake Lure city limits, at a cost of \$260.00. Mr. Garner agreed to check with Mitchell Sign Co. in an effort to obtain them for less. If unable to do this they will be purchased as mentioned above. This was seconded by Jim Nance. The vote was unanimous.


Mr. Don Cothran asked about purchasing play ground equipment.

A motion was made to run an ad in the Rutherfordton paper for the purpose of hiring two employees to work for the Town. The vote was unanimous.
