

MINUTES OF A REGULAR MEETING
OF THE BOARD OF COMMISSIONERS OF
THE TOWN OF LAKE LURE, N.C.

The regular meeting of the Board of Commissioners was held in the Town Hall on August 13, 1974. The meeting was called to order by Mayor Wilson at 7:35 P.M.

The minutes of the last meeting were read.

Mr. Bell recommended in the future to eliminate Voluntary Policemen, if need be to hire additional men.

Claude Nelson reported that Steve Pinker was back in the Junior Police.

Motion was made by Mayor Wilson to adopt the minutes, seconded by Jim Nance.

Minutes of the Special Meeting held July 16, 1974 was read by Mary Ficker. Mayor Wilson ask Chief Swaringen to explain the Forensic Equipment which consist of Camera, Finger Printing Equipment, and Equipment for the Dark Room. The motion was adopted by Jim Nance, seconded by Mayor Wilson.

Mayor Wilson ask if there was any new business.

Mr. Harris, representing Larry Phillips, made a request that the El Tango be allowed to operate until 1 A.M. during Eastern Daylight Time. Action was tabled on this request until the Town Ordinance could be checked.

Mr. McKinney ask why the gates at the Dam was not raised to avoid flooding of his property. Mr. Wilson explained how the water was controlled at the gates and that it took a period of several hours to regulate it. The Town Attorney, Mr. Nesbitt, suggested a meeting be set up between the Councilmen and Mr. McKinney's Attorney.

The Resolution on the Mudcat was tabled until the next meeting.

Motion was made by Mayor Wilson, seconded by Jim Nance, that the Town of Lake Lure pay the Hickory Nut Gorge Fire Department \$1,500.00 for fire protection.

Mr. Nesbitt requested that copies of the Codified City Ordinances be placed in the following places: County Court House, one in the Office, and a copy to each policeman.

Mayor Wilson made a motion that the meeting be adjourned.
The motion was seconded by Jim Nance.
