## RESOLUTION BY GOVERNING BODY OF APPLICANT

- WHEREAS, The North Carolina Clean Water Bond Act of 1971 has authorized the making of grants to aid eligible units of government in financing the cost of construction of wastewater treatment works, wastewater collection systems, and water supply systems, and
- WHEREAS, The Town of Lake Lure has need for and intends to construct a water supply system project described as Water System Improvements for Town of Lake Lure, and
- WHEREAS, The Town of Lake Lure intends to request State grant assistance for the project,

NOW THEREFORE BE IT RESOLVED, BY THE CITY ALDERMEN OF THE TOWN OF LAKE LURE

That the Town of Lake Lure will arrange financing for all remaining costs of the project, if approved for a State grant award.

That the Town of Lake Lure will provide for efficient operation and maintenance of the project on completion of construction thereof.

That Mayor J. Paul Wilson is hereby authorized to execute and file an application on behalf of the Town of Lake Lure with the State of North Carolina for a grant to aid in the construction of the project described above.

That Mayor J. Paul Wilson is hereby authorized and directed to furnish such information as the appropriate State agency may request in connection with such application or the project; to make the assurances as contained above; and to execute such other documents as may be required in connection with the application, grant offer, or grant award.

That the Town of Lake Lure has substantially complied or will substantially comply with all Federal, State, and local laws, rules, regulations, and ordinances applicable to the project and to Federal and State grants and loans pertaining thereto; and hereby authorizes the above designated representative to execute an affidavit so stating.
