## MINUTES OF A REGULAR MEETING OF THE BOARD OF COMMISSIONERS OF THE TOWN OF LAKE LURE, N.C. NOVEMBER 28, 1978

The regular meeting of the Board of Commissioners was held in the Community Building November 28, 1978 at 7:30 p.m. The following members were present: Mayor J. Paul Wilson, Commissioners Claude R. Nelon, A.T. Cashion, Jr., William O. Keller, Henry E. Rainey and Town Attorney Martin L. Nesbitt, Jr.

Mayor Wilson called the meeting to order and minutes of a regular meeting held on October 24, 1978 were read. Motion was made by Commissioner Nelon, seconded by Commissioner Cashion they be accepted as read and the vote was unanimous.

Mayor Wilson read minutes of a special meeting held on November 14th. A copy is attached to the minutes.

Commissioner Nelon reported the Town crew began today putting gravel on roads and a movie and discussion Wednesday December 6th at 9:00 a.m.in the Community Building. This being presented by the Urban Forestry Service. He then suggested a \$50.00 pay increase for Town employees who have been on the payroll for at least one year. The increase will be for the period starting 12/8/78 and ending 12/14/78. The entire Board agreed to the increase.

Jack Donaldson gave the fire report for November. A copy is attached to the minutes.

The Board discussed possible designes for Lake Lure city limits signs. It was suggested by Mayor Wilson the Board ask Jenell English if she would sketch some of her ideas.

Lynn Bociek expressed her disapproval of a trailer being hooked on to the city water line below her. After a long discussion on water pressure etc. Commissioner Cashion promised to check the water line at her house Thursday morning.

The next subject for discussion was a petition signed by residence of Sunset Cove protesting a trailer that was placed in the cove. Commissioner Cashion made a motion the Attorney write a letter informing Mr. Linn he is in violation of a Town Ordinance and include a copy of the ordinance, seconded by Mayor Wilson the vote was as follows: Mayor Wilson-yes, Claude Nelon-yes, A.T. Cashion, Jr.-yes, William O. Keller-no, Henry E. Rainey-yes. Commissioner Nelon made a motion to amend Building Ordinance M.O. 10-1 Building Restrictions to include trailers and temporary structures, seconded by Commissioner Cashion the vote was unanimous.

There being no further business motion was made by Commissioner Keller, seconded by Commissioner Rainey the meeting be adjourned. The vote was unanimous.

## AMENDMENT TO M.O. 10-1 BUILDING RESTRICTIONS

The Board of Commissioners of the Town of Lake Lure, North Carolina, do ordain as follows:

That paragraph "1" of M.O. 10-1, Building Restrictions, adopted on the 8 day of October, 1974 is hereby amended, in that paragraph "1" shall read as follows:

All persons, firm or corporations desiring to construct any new structure or locate a mobile home or temporary shelter within the Corporate Limits of the Town of Lake Lure shall, prior to any construction, obtain a building permit from the Town of Lake Lure.

The aforesaid ordinance shall be subject to the penalties as set forth in the original M.O. 10-1, section "E".
