

MINUTES OF A SPECIAL MEETING
OF THE BOARD OF COMMISSIONERS OF THE
TOWN OF LAKE LURE, N.C.
MAY 28, 1982

A special meeting of the Board of Commissioners was held in the Town Office May 28th at 9:00 a.m. Members present: Mayor Charles Hicks, Commissioners David Bond and Frankie Queen.

The meeting was called to order for the purpose of opening bids for a chain link fence. Bids are as follows: S & S Fence \$3,123.00, Hendersonville Fence \$2,035.00. A bid from Bagwell Fence was still in the mail. No action was taken to allow for further study.

Upon discussion motion was made by Commissioner Bond, seconded by Commissioner Queen to authorize Town Attorney to negotiate a proposed contract agreement with Cable TV Co., Inc. and report to the Town Council for adoption consideration. To expend up to \$600.00 for professional expertise to be recovered from Cable TV. The vote was unanimous.

Motion was made by Commissioner Bond, seconded by Commissioner Queen the meeting be recessed until Tuesday June 1st at 9:00 a.m. The vote was unanimous.


JUNE 1, 1982


After discussion motion was made and seconded to place two Porta-johns on the west end of the beach at the gate. The vote was unanimous.

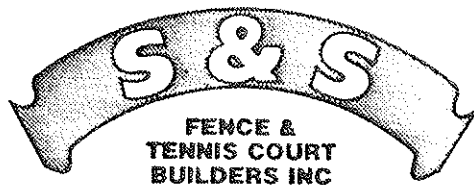
