

MINUTES OF A REGULAR MEETING  
OF THE TOWN COUNCIL  
NOVEMBER 22, 1983

The regular meeting of the Town Council was held in the Community Building at 7:30 p.m.

Those present were: Mayor Hicks, Commissioners Gruver, Cashion, Price and Queen, and Town Attorney Jervis Arledge.

The meeting was called to order after the invocation by the Rev. Griffiths.

Council approved a request of Sherry Hill to rent the Community Center for exercise classes. Sessions will be two nights each week for five weeks beginning in January. Rental fee was established at \$50.00 for the 10 sessions.

Council voted to enter executive session for the purpose of discussing personnel.

Following the executive session, Council voted to return to regular session.

Council voted to terminate Mrs. Mary Ficker and S.R. Swaringen Town employees. The vote was 3 "yes" and one "no".

Council voted to terminate Mrs. Marlene Wilson as a Town employee. The vote was three "yes" and two "no", with Mayor Hicks casting the tie breaking vote.


Council voted to grant two weeks severance pay to the terminated employees and to pay for any accumulated vacation time.

When asked for a reason for the employees termination, Mayor Hicks stated that the Council had elected to make no statement concerning the termination.

There being no further business motion was made and seconded to adjourn. The vote was unanimous.
