

MINUTES OF A SPECIAL MEETING
OF THE BOARD OF COMMISSIONERS
OF THE TOWN OF LAKE LURE

July 15, 1985

A special meeting of the Board of Commissioners of the Town of Lake Lure was called Monday, July 15, 1985 in the Town Office for the purpose of discussing lake safety and the Lake Lure fire department. Those present were: Mayor Charles F. Hicks, Commissioners Price, Gruver, Queen and Cashion, Town Manager Norman Newell and Town Attorney Chris Callahan.

Commissioner Cashion made a motion, seconded by Commissioner Gruver to dispense with the reading of the minutes of the last meeting. The vote was unanimous.

Commissioner Cashion made a motion to adopt a Resolution instructing the Town Manager, in conjunction with the Town Attorney, to research and develop an ordinance which covers the following areas:

- 1) "no wake" speed in the harbour area
- 2) watercraft propelled by an above water exhaust system
- 3) all watercraft which is covered in such a manner as to prevent a clear view of the occupants

Commissioner Gruver seconded the motion and the vote was unanimous.

Motion was made by Commissioner Cashion, seconded by Commissioner Price to prohibit all water craft that contain living-quarters therein, including houseboats, from Lake Lure. The motion was unanimous.

Motion was made by Commissioner Price, seconded by Commissioner Gruver to recess for five minutes and reconvene in Dr. Burch's office. The vote was as follows:

Commissioners Gruver, Price and Queen in favor.
Commissioner Cashion against.

Those present at the meeting moved to Dr. Burch's office and a motion was made by Commissioner Price seconded by Commissioner Gruver to reconvene the meeting in joint conference with members of the Lake Lure Fire Protective Association. Those present from the Association were: Brian Gruver, Jim Hook, Harry Hammett, Charles Moore, Dr. Burch, Robin Parton, and Fire Chief Joe Goodwin.

After a lengthy discussion about the problems between the Lake Lure Fire Department and the Town Council, the motion was made by Commissioner Cashion to recess for five minutes and reconvene again in the Town Office. The motion was seconded and the vote was unanimous.


The meeting was reconvened and further discussion regarding the fire department ensued. After several minutes discussion Commissioner Cashion made the following motion:

I move that the Town sever relations with the Lake Lure Fire Protective Association and instruct the Town Manager to proceed with the formation of a town fire department, utilizing a paid chief and volunteer fire fighters.

Commissioner Price seconded the motion and the vote was as follows:

Commissioners Cashion, Gruver and Price in favor
Commissioner Queen against

Commissioner Cashion made a motion, seconded by Commissioner Price to adjourn. The vote was unanimous.
