SPECIAL MEETING OF THE LAKE LURE TOWN COUNCIL HELD AT THE LAKE LURE COMMUNITY CENTER THURSDAY, NOVEMBER 17, 1988 AT 9:30 A.M.

Mayor Michelon called the meeting to order at 9:30 a.m.

The first item on the agenda was the "Proposed Communication Network".

There being no communication to get in contact with the dam, public works, etc, it was suggested that we needed a better form of Town wide communication, in addition to the emergency number - 911. This would permit fire, police, EMS, and public service personnel to contact each other immediately and directly.

Commissioner Wildman moved to appoint Dick Weaver and Evin Goodwin to the Zoning and Planning Board, effective December 1, 1988. Dick Weaver and Evin Goodwin would be put in as regular members. This will require that Paul Wilson, Town Manager, will serve as an alternate appointee member of the Zoning and Planning Board. His resignation as a regular member will become effective as of December 1, 1988. Commissioner Moirano seconded the motion and the vote of approval was unanimous.
