SPECIAL MEETING OF THE LAKE LURE TOWN COUNCIL HELD WEDNESDAY, MAY 8, 1991 AT 2:00 P.M. AT THE LAKE LURE COMMUNITY CENTER.

Citizen's of Lake Lure were allowed to come in and discuss with Council members their questions and complaints.

Larry Phillips inquired about the possibility of conditional use zoning being expanded. Mayor Michelon announced that all of the possible modifications of C-1 zoning will come before the Council in June 1991 at a public hearing.

Mr. Dick Seguin requested that a chlorine count be done to determine the count of bacteria on the lake. He suggested the count should be done possibly each Monday during the heat of the day. In a related matter the Council decided to recheck the chlorine count below the dam, to avoid any future fish kills.

Dr. Fred Doyle, a citizen of Lake Lure, recommended that multiple samples should be taken on the coliform counts at different parts of the day. It was the consensus of the Council that the Manager would pursue to have this matter taken care of as soon as convenient.

Joe Goodwin questioned the matter of illegal signs, particularly signs from Mountain Lake Realty, which remain at Lake Lure Village Resort. Commissioner Bush recommended that the Zoning Administrator get a letter to Betty Cashion giving her 24 hours to get the signs down.

Joe Goodwin also referred to Article 1315 - Directory Signs. He felt that, if they are going to be allowed, for commercial businesses, the sign ordinance should be changed.

Melvin Owensby inquired into the ordinance on domestic animals and fowl. He felt that if he should have to remove his chickens from his property, then other citizens should have to remove their animals -- such as goats, dogs, horses, chickens, etc. Page 2 - MINUTES OF THE WEDNESDAY, MAY 8, 1991 COUNCIL MEETING
