INVOCATION

Mayor Pro-tem Max Lehner called the meeting to order at approximately 7:30 p.m. Reverend Mark Dunn gave the invocation.

APPROVAL OF MINUTES

Commissioner Bush moved, seconded by Commissioner Karr, to approve the minutes of the Tuesday, February 25, 1992 Regular Town Meeting, Tuesday, March 10, 1992 Recessed Town Meeting, and Tuesday, March 17, 1992 Recessed Town Meeting. The vote of approval was unanimous.

AUDIENCE OF CITIZENS

Commissioner Donovan announced the "Beat the Council" Golf Tournament scheduled for Saturday, March 28, 1992. The cost is \$60 per team.

ACTIVITIES HONORING WALTER RUST

Mr. Walter Rust, resident of Lake Lure, was honored for his dedication to the Town of Lake Lure. Claude Nelon and Dick Neher spoke on behalf of Mr. Rust.

Commissioner Karr and his wife Mary presented Walter with a "Key to the Town", on behalf of the Town to show appreciation for all of Walter's dedication to Lake Lure.

DISCUSSION OF CABLE TELEVISION SERVICE

CALL FOR PUBLIC HEARING TO BE HELD IN CONJUNCTION WITH APRIL 28,1992 MEETING OF TOWN COUNCIL TO CONSIDER ADOPTION OF REVISED ZONING MAP AS RECOMMENDED BY THE PLANNING AND ZONING COMMISSION

The Lake Lure Planning and Zoning Board recommended that the Lake Lure Town Council adopt the Zoning Map as presented.

The Planning Board has reviewed the Zoning Map in an effort to better define zoning boundaries and to establish a map which can be used in conjunction with the updated Zoning Ordinance. A brief summary of the major changes recommended follows: PAGE 4 OF THE MINUTES OF THE TUESDAY, MARCH 24, 1992 TOWN MEETING

- 1. The map has been transcribed onto tax maps to more easily identify the zoning of particular lots.
- The lake area is currently showed zoned R-1. The revised map shows the lake zoned L-1, Lake District.
- 3. The area around the Hydro-Electric Plant is currently shown as M-1, Mountainous District. The Board recommends this be changed to R-2 which allows a publicly-owned facility to be placed there.
- 4. The commercial zone along U.S. Highway 64/74 and directly across from the Community Center has been more closely defined to run along existing property lines. The Board recommends that this commercial zone extend to a depth of 200 feet from the highway and be zoned R-2 beyond that depth.
- 5. The Lure Woods area, currently zoned R-3, would be zoned R-1 to a distance of 500 feet from the lake and beyond that depth would remain R-3.

The Planning and Zoning Board feels that these proposed changes will more accurately reflect the Town's zoning and respectfully recommends that the Town Council adopt the revised map.

Mr. Jim Barrett of Maw and Paw's Mountain Store requested Council to rezone their business property from R-1 to C-1. Council suggested that Mr. Barrett go before the Planning and Zoning Board with his request.

Commissioner Bush moved, seconded by Commissioner Karr, to call for a public hearing Tuesday, April 28, 1992 at the Lake Lure Community Center at 7:30 p.m., for the purpose of considering adoption of the revised zoning map as recommended by the Planning and Zoning Board. The vote of approval was unanimous.

F. E. Isenhour, Zoning Administrator, announced that first class notification of the public hearing will be sent to all property owners that we have on our list.

Commissioner Karr moved, seconded by Commissioner Bush, to release the taxes, as presented by Tax Collector, in the amount of \$22.29. The vote of approval was unanimous.

REQUEST FROM DOGWOOD FESTIVAL COMMITTEE

Commissioner Bush moved, seconded by Commissioner Donovan, to suspend the current Peddler's Ordinance for the week of April 10 through April 13, 1992 for the Dogwood Festival. The vote of approval was unanimous.

Upon motion made by Commissioner Bush, seconded by Commissioner Donovan, the following ordinance unanimously adopted:

Be it ordained that Municipal Ordinance 61.01 is hereby suspended for the period April 10, 1992 at 1:00 a.m. through April 13, 1992 at 11:00 p.m. for the purposes of the Dogwood Festival.

STAFF REPORTS

Mr. Hord reported on the Wastewater Treatment Plant which is approximately 85% complete and will meet the July 31st deadline.

Mr. Hord also reported that the Department of Transportation announced they will be resurfacing Highway 64/74 from approximately the Green Hill School area to the Henderson County Line. Commissioner Bush recommended that the Town Manager look into having reflectors put onto the road during the resurfacing process.

Mr. Hord reported that we would be mailing out a newsletter first class the end of this month to give notification of the public hearing scheduled to be held at the April Regular Town Meeting.

Mayor Pro-tem Max Lehner publicly thanked Mary Flack for her contribution to the Resolution drawn up for Walter Rust.

Mr. Hord thanked Fairfield for their hospitality during the Town Meeting.

With no further items of discussion, Commissioner Bush moved, seconded by Commissioner Donovan, to recess to Tuesday, March 31,

RESOLUTION

A RESOLUTION OF THE TOWN COUNCIL OF LAKE LURE, NORTH CAROLINA CREATING A LAKE ADVISORY COMMITTEE TO ADVISE COUNCIL ON MATTERS RELATING TO THE SAFE AND ENJOYABLE USE OF LAKE LURE

Whereas, the Town of Lake Lure is very fortunate to own and control one of the most beautiful fresh water lakes in the Nation; and,

Whereas, in order to protect the health and safety of persons using the lake it has become necessary to establish rules and regulations to govern the safe use of Lake Lure; and,

Whereas, the Town Council of Lake Lure, North Carolina finds that it is in the best interest of the Town to authorize and create a special Lake Advisory Committee to study and make recommendations to Council concerning the safe and enjoyable use of Lake Lure; and,

NOW THEREFORE BE IT RESOLVED BY THE MAYOR AND TOWN COUNCILMEN OF LAKE LURE, NORTH CAROLINA:

Section 1: That there is hereby and herewith created a Lake Advisory Committee to provide recommendations and advice to the Town Council on matters concerning the safe and enjoyable use of Lake Lure.

<u>Section 2</u>: That the Lake Advisory Committee advise and make recommendations to Town Council on matters referred to it by Council which could include such activities as:

- (A.) Revisions to policy regulating the construction and use of structures on Lake Lure;
- (B.) Enforcement of regulations to create a safer environment for all who use the lake;
- (C.) A community network that could handle warnings and clean-up operations before and after major storms;
- (D.) The various ways of improving fishing on Lake Lure;

- (E.) Silt removal, dredging, and other methods that could be used to improve the eco-system of the lake;
- (F.) Boat use regulations, no-wake zones, and navigational aids.

<u>Section 3</u>: That the Committee shall consist of eight members each appointed by a majority vote of Town Council.

Section 4: That the term of appointment of each member shall be for two years, except in appointing the original members of such committee, the Council shall designate four members for one year terms, with the other four original members being appointed to the usual two year terms, thereafter the terms of all members shall not expire at the same time.

<u>Section 5</u>: That vacancies on the Lake Committee shall be filled by vote of Town Council to fill the unexpired term.

<u>Section 6</u>: That members of the Lake Committee annually shall elect from their membership a Chairman, Vice-Chairman, and Secretary to fulfill the normal responsibilities of such offices.

<u>Section 7</u>: That meetings of the Lake Committee be held in a public meeting room, be opened to the public and held as often as reasonably needed to accomplish the business of said Committee.

Section 8: That the Lake Committee make its recommendations to Town Council in written form in a timely manner and may be requested to make oral reports at Council meetings.

<u>Section 9</u>: That all orders and resolutions in conflict herewith be and the same hereby are repealed insofar as such conflict exists and this resolution shall become effective immediately upon its passage.
